Any correction will be done by scoring out the incorrect entry and inserting the new entry in a legible manner. Both the correction and new entry to be signed and sealed with Company's seal. In the event of any difference between figure & words of the quoted rates, the rate in word shall be considered for evaluating the tender. Tenders to be submitted in two parts:-

1. Raw Material for H.T. Rivet Bars should be Killed/Semi-Killed quality as indicated in IS:1149 and the same to be procured from any of the E.C. Railway's approved manufacturers viz. SURYA ALLOY INDUSTRIES LTD, SUNFLAG IRON & STEEL COMPANY LTD. / R.I.N.L. / INDIA SUPERCRAFT INDUSTRIES LTD. Raw materials of above specification may also be procured from any other reputed manufacturers to be proposed by the bidder subject to approval of samples by E.C. Railway after testing from E.C. Railway's approved/authorized laboratories. Before commencement of manufacture of rivets the rivet manufacturers must submit documentary evidence such as challans, test certificates etc. substantiating the raw materials and their sources.
2. Each rivet head must contain embossed "HT" and rivet manufacturer's identification marking.
3. Quality assurance Plan to be strictly followed and enclosed as ANNEXURE-A.

SPECIAL CONDITION OF CONTRACT

1. DEFINITIONS AND INTERPRETATION:

In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under:

- a) “**BBJ**” shall mean The Braithwaite Burn & Jessop Construction Company Limited having its registered Office at 27, R. N. Mukherjee Road, Kolkata- 700 001.
- b) The “**TENDER**” shall mean the proposal submitted by the Tenderer/ Bidder in response to BBJ’s Notice of Invitation to this Tender Document.
- c) The “**ORDER**” shall mean a written Purchase Order issued by BBJ.
- d) The “**SUPPLIER**”/”**RIVET MANUFACTURER**” shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBJ.
- e) E.C. RAILWAY shall mean EAST CENTRAL RAILWAY and/or their Authorized Representatives.

2. SCOPE OF SUPPLY:

As per technical Specification –TS-1:

SITE RIVET

24MM DIA. – 236.006 MT (APPROX.)

3. VARIATION IN QUANTITIES:

The BBJ reserves the right to alter the sizes & quantities of the rivets. If due to change in the sizes & quantities of the rivets, there be variations, resulting in increase or decrease in quantities, payment will be made only for the actual quantities supplied at the ordered rates. If there be sufficient cause, the BBJ may grant extension of the date of completion suitably. Such circumstance, shall in no way affect or vitiate the contract or alter the character thereof, or entitle the supplier to damages or compensation there for except as provided for in this contract.

4. SPLITTING OF SCOPE OF SUPPLY

BBJ reserve the absolute right to split the SCOPE OF SUPPLY in respect of SIZE & QUANTITY among the Techno-commercially qualified bidders as per BBJ’s requirement and decision. However, in such case the L1 bidder will get 60% or more of the total quantity depending upon the requirement of BBJ.

However, any party will not have any claim towards reduction of such quantity from their scope of supply and such splitting of Scope of Supply will be done at Negotiated Lowest Accepted Rate only. The splitting of scope of supply will be done as per following:

- **LOWEST BIDDER** – 60% (Sixty percent) or more ;
- **OTHER BIDDERS** – 40% (Forty percent) or in equal proportion only as the case may be.

Order quantity will be reviewed periodically by BBJ and considering the status of production and supply of rivets, quantities may be revised/ reduced as per BBJ's requirement to suit the project work. BBJ's decision in this regard will be final and binding on the supplier(s) and no claim will be entertained on this account.

5. INSPECTION:

By BBJ, QA and/or E.C. RLY or their Authorized Representative.

The following aspects may be noted in this regard :

- a) The inspection Agencies will conduct all tests as prescribed in QAP (enclosed as ANNEXURE-A) before issuing of Test Certificate.
- b) The Test Certificate shall cover all the test results as per specifications laid down in the QAP mentioned above.
- c) In addition to above, random samples of the rivets shall be collected by BBJ and/or E.C. Railway for Third Party Testing at any stage to confirm the fulfilment of the acceptance criteria.
- d) In case of rejection of rivets at any stage by any of the above inspection agencies, the defective lot/lots of rivets must be replaced by the supplier by a fresh lot with further inspection and testing by the inspection agency nominated by BBJ within a reasonable time without any extra cost to BBJ. Inspection and test report clearing this replacement lot with positive test results and confirming all the requirements must be submitted before dispatch. Inspection certificate shall not absolve the supplier from replenishing defective rivets at any stage.
- e) Inspection Charges will be reimbursed by BBJ at actual on submission of all the relevant documentary evidences along with bill against delivery subject to acceptance of the lot by the inspection agency.

6. FIRM PRICE:

Rate shall remain firm and shall not attract escalation due to any reason such as Steel price hike whatsoever in pursuance of this contract during the delivery period or upto the extended delivery period as the case may be from the date of order.

7. PAYMENT TERMS:

Within 30 days after receipt of clear bill.

8. DELIVERY:

Delivery to be made at Ganga Bridge Site, Munger (Bihar).

9. Delivery Period

Total delivery to be completed within 5 (five) months from date of LOI or Purchase order in phases consisting of each size as per BBJ's requirement as per following:

a) **FIRST PHASE** – 25% of total ordered quantity within 1¹ (One) month from the date of LOI/Purchase Order whichever is earlier.

b) **SECOND PHASE** – 25% of total ordered quantity within 2½ (Two and half) months from the date of LOI/Purchase Order whichever is earlier.

c) **THIRD PHASE** – 25% of ordered quantity within 4 (four) months from date of LOI or Purchase order whichever is earlier.

d) **FOURTH PHASE**- Balance 25% of ordered quantity within 5 (five) months from date of LOI or Purchase order whichever is earlier.

10. DELIVERY PERIOD EXTENSION

If there is delay for reasons not attributable to the Supplier, BBJ upon receipt of written request justifying such delay from the Supplier may extend the Delivery period as suitable and fit reasonable to BBJ. No extra claim of supplier will be entertained in such cases of time extension being granted.

11. GUARANTEE :

Supplier will stand guarantee for the quality supplied item. If the supplied Qty. found defective, the defective quantity to be replaced by the supplier at their risk and cost.

12. LIQUIDATED DAMAGE:

If the Supplier fails to supply the quantity within stipulated delivery period, as mentioned in the order, 0.5% (half percent) of balance order value will be deducted from bill for per week

of delay or part thereof subject to a maximum of 5% (five percent) of the total order value.

13. TERMINATION OF CONTRACT:

In case of failure to discharge the duties as per our requirement, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the supply done by deploying other agency /agencies. Cost incurred for the above shall be recovered from the supplier's bill and Security Deposit.

14. JURISDICTION OF COURT:

The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.
