**Notes :-**Manufacturer or their valid authorized dealer(s) is/are only entitled for submission their offer. **Authorised dealer(s) should submit their valid Authorisation Certificate, VAT Registration Certificate and Copy of PAN Card along with their offer, otherwise their offer will not be considered.**

3. **Validity of Rate :** Your quoted rate should be valid and firm for a period of 3(three) months from the date of your offer.

4. **Delivery at** :- BBJ Ganga Bridge Site, Munger (Bihar) **along with Manufacturer's Test Certificate or Guarantee/Warranty Certificate.**
5. **Delivery Period**: - Within 15 days from the date of LOI/ORDER.
6. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan.
7. **Earnest Money Deposit** :- An amount of **Rs.5,000.00** (Rupees five thousand only) to be submitted with individual offer, as EMD amount in form of account payee Demand Draft/Pay Order/Banker's Cheque in favour of "The Braithwaite Burn And Jessop Construction Company Limited", payable at Kolkata. Unsuccessful bidders will be refunded the Earnest Money Deposit amount after the award of the contract/order to the successful bidder.  
The EMD amount of successful bidder will be released within 30 days after completion of total supply/service/installation/work without any interest subject to receipt of written request from the successful bidder.

  - (d). For existing supplier(s), the EMD amount may be adjusted from their passed bill(s) amount, subject to submission of their written declaration with their offer in connection with adjustment of their EMD amount from their outstanding bills if any.
8. **Liquidated Damage** :- If you fail to complete supply as per our order within stipulated period, 0.5% of order value will be deducted from your bill for per week of delay subject to maximum of 5% of order value.
9. **Termination of Contract**:- If the supplier failure to complete the total work/supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours notice. Additional cost if incurred shall be recovered from the supplier's bill.
10. **JURISDICTION OF COURT**:  
The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.
