INSTRUCTION TO TENDERERS

01.	Registration of bidder: Any supplier/agencies willing to take part in this e-Tendering will have to be enrolled & registered with the Government e-Procurement system, through logging on to https://eprocure.gov.in/eprocure/app
02.	Digital Signature certificate (DSC): Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders, from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount. Details are available at website (https://eprocure.gov.in/eprocure/app) in Clause 2 of Guideline to bidder. DSC is given as a USB e-Token.
03.	ELIGIBILITY CRITERIA: Bidder must submit the following documents:- a) The bidder should have successfully executed services of providing <u>similar cranes on Hire basis</u> for Public Sector Undertaking (PSU)/Central Govt./State Govt./Autonomous body/reputed companies during <u>last five (5) years</u> ending as on the date of publication of this tender. b) Detailed Load Chart & other legal documents (i.e ownership of crane, tax & insurance clearance of crane, valid licence of crane operator etc.) of the crane to be provided. c) Proof of availability of cranes at site. d) The make, model No., year of manufacture of the crane to be deployed by them for the subject work.
04.	SUBMISSION OF e-BID: Tenders to be submitted online in CPP's Portal in two parts:
(A)	TECHNO-COMMERCIAL e-BID: Copy of the following document, duly signed in each page, must be uploaded in CPP's portal (https://eprocure.gov.in/eprocure/app):
(i).	Experience certificate & other documents, as stated in the eligibility criteria. Copy of relevant document/work Order/Job completion certificate from clients duly signed & stamped in each pages proving your past experience to be submitted.
(ii).	Copy of the following documents duly signed & with official stamped:- a) Copy of PAN along with Income Tax Return (ITR) for last three (03) years; b) Copy of Good & Service Tax registration Certificate, c) Copy of NSIC certificate for SSI/MSE units. d) Document showing the person legally authorised to enter into commitment on behalf of the bidder.
(iii). (B)	PRICE PART i.e Financial e-BID: Properly filled up Schedule of Rate/Bill of Quantities (BOQ) is to be uploaded in CPPP website. Price bid of only those bidders will be opened whose Techno-commercial offers are found to be qualified and acceptable to BBJ. SAC code must be provided against each BOQ items.
05.	Conditional tenders shall be straightway rejected and no additional clause will be entertained.
06.	BBJ reserves the right to accept/reject any or all of the tenders and split the scope of work into more than one agency in the ratio of 60%:40% between L1 & L2 bidders respectively (provided L2 bidder accepts L1 rate) without assigning any reason whatsoever. No claim will be entertained on account of this.
07.	VALIDITY OF TENDER: 90 (Ninety) days from the date of opening of tender or for a further period if mutually accepted.
08.	LANGUAGE: Bids and all accompanying document shall be in English. In case any accompanying documents are in other language, it shall be accompanied by an English translation. The English version shall prevail in matter of interpretation.
09.	The bidder/crane supplier/agency must visit our Kharsia Site (Bridge no. 17) to observe actual site conditions etc., before quoting e-bid/rates.

SPECIAL CONDITION OF CONTRACT

SCC-1

1. DEFINITIONS AND INTERPRETATION:

In this Tender, here-in-after defined, the following words and expressions shall have the meaning as under:

- a) "**BBJ**" shall mean The Braithwaite Burn And Jessop Construction Company Limited having its Head Office at 27, Rajendra Nath Mukherjee Road, Kolkata- 700001.
- b) The "**TENDER**" shall mean the proposal submitted by the Tenderer/Bidder in response to BBJ's e-NIT.
- c) The "**ORDER**" shall mean a written Work Order issued by BBJ.
- d) The "**PARTY**" shall mean the person, firm or Company (here-in-after called Tenderer) who's Tender has been accepted by BBJ.

2. SCOPE OF WORK:

- a) One (1) no. Crawler Mounted Mobile Crane having minimum 40 Ton capacity with 90Ft. boom length to facilitate erection of 30.5m span welded truss girders for bridge site no. 17 at Kharsia, Chhattisgarh.
- b) Loading, unloading, handling, re-handling of bridge components, other steel materials and wooden materials, launching, erection and dismantling of steel bridge components from the date of deployment of above crane.
- c) **Deployment period:** Hiring Period of the above crane will be for Two (2) months from the date of deployment of crane at project site. However the hiring period may increase/decrease as per decision of Site-In-charge/Project-in-Engineer of BBJ as same rate, terms & conditions as per order.
- d) **Duty hours:** 12 (Twelve) hours shift i.e 8 A.M. to 9 P.M., Lunch break up 12 Noon to 1 P.M. However, the Site-in-charge/Site Engineer of BBJ, Kharsia site, may change the duty hours as per requirement. Duty hours of the crane to be noted in the Time Sheet/Log Book duly signed by site-in-charge/Site Engineer of BBJ, Kharsia site or his nominated representative.
- e) Skilled Crane operator along with valid license, documents, certificates to be provided with the Crane. Any other staff/helper, if required, for operating the crane to be arranged by the crane supplier at his cost.
- f) All necessary safety devices for the Crane and the Crane operator including helper to be provided by the party.
- g) All necessary valid documents in connection with the above Crane to be provided during operation of the Crane at site by crane supplier.
- h) **Fuel & Lubricant** – For running the Crane, fuel and lubricant will be provided by the Crane supplier.
- i) **Breakdown** – In case of any breakdown during the working hours, the hours lost during repairing of the Crane will be deducted from the bill as per time sheet / Log sheet.
- j) **Maintenance or repairing of the crane:** To be done by the crane supplier at his risk and cost. Any cost toward accident/damage/lost during operation/hiring period of the above Crane to be borne by the crane supplier. BBJ will not be responsible for any contractual/Legal obligation in this matter. Any major & minor repair of the crane are to be provided by the crane supplier
- k) **Accommodation & Transportation cost:** Accommodation, Transportation, Fooding cost of crane operator and other helper (if required) will be provided by the crane supplier.
- l) To & fro transportation, mobilization and demobilization of the crane;

3. FIRM PRICE:

Your rate shall remain firm and shall not attract escalation, due to any reason, such as diesel price hike etc. whatsoever in pursuance of this contract during the contract period.

4. PAYMENT TERMS:

Within 30 days from the date of submission of clear bill duly certified from the BBJ's project site, after completion of One (1) Month from the date of deployment of crane.

5. SECURITY DEPOSIT:

Earnest Money Deposit (EMD) by the bidder will be converted into security deposit and will be retained by BBJ till successfully completion of erection work at Talcher site, without any interest and will be released on receipt of application from the bidder.

If the contract become rescind due to reasons attributable to contractor for non-completion of work, the Security Deposit of the contractor shall be forfeited.

6. GOODS AND SERVICE TAX (GST):

- a) **The quoted price shall be exclusive of Goods and Service Tax.** The GST, as legally leviable & payable by the bidder under the provisions of applicable law/act, shall be paid extra by BBJ as per bidder's bill. **Bidder shall quote their rate after considering the input tax credit on their input services.**
- b) At present no GST-TDS is applicable. If the same is applicable in future, deduction of GST-TDS at source would be enforced from the running bills at the rates prescribed. The GST (i.e. SGST, CGST or IGST) amount shall be shown separately in invoice and also submit proper Tax Invoice as per section 31 of CGST Act, and Rule 46 of CGST Rules, 2017 to get Input Tax Credit by BBJ.
- c) **Bidder shall raise their tax invoice in regular interval as per contract condition and uploaded their supply invoice in GSTN Portal through GSTR-1 return with 10th of next month. Mismatch in return of BBJ due to any reason attributable to bidder, the same shall be recovered from Bidder's bill.**
- d) The contractor shall be exclusively responsible for payment of all other Taxes, Royalties etc. (except Goods and Service Tax) that may be levied from time to time according to the Laws & regulation now in force & also hereafter to be imposed, increased or modified from time to time. Nothing will be payable extra by the Company in respect of any duties/taxes to be imposed for providing of service e for execution of contract.
- e) In case Government imposes any new levy/tax after award of the work, during the tenure of the contract, BBJ shall reimburse the same at actual on submission of documentary proof of payment, subject to the satisfaction of BBJ that such new levy/tax is applicable to this contract.
