INSTRUCTION TO TENDERER

01.	"SUBMISSION OF TENDER" shall be read in conjunction with General Commercial Terms and conditions and any other documents forming part of this Tender Document wherever the context so requires. Notwithstanding the sub-division of the documents into the separate section, every part of each shall be deemed to be supplementary to and complementary to every other part and shall be read with the document so far as it may be practicable to do so wherever it is mentioned that the Sub-Contractor shall perform certain work or provide certain facilities, it is understood that the Sub-Contractor shall do so at their cost.
02.	<u>LANGUAGE</u> Bids and all accompanying document shall be in English. In case any accompanying documents are in other language, it shall be accompanied by an English translation. The English version shall prevail in matter of interpretation.
03.	<u>SUBMISSION OF TENDER</u>
a)	The Tender shall be signed by the person legally authorised to enter into commitment on behalf of the Tenderer.
b)	All the pages of the tender document to be signed with Company's seal by the Tenderer. The rates in the appropriate space in the BILL OF QUANTITIES should be properly filled, both in figures and words. No overwriting, using of correction fluid will be allowed. Any correction will be done by scoring out the incorrect entry and inserting the new entry in a legible manner. Both the correction and new entry to be signed and sealed with Company's seal. In the event of any difference between figure & words of the quoted rates, the rate in word shall be considered for evaluating the tender.
c)	The tender is to be submitted in a sealed cover and superscribed with Tender Reference, Due Date marked for the Deputy General Manager(M&CP), The Braithwaite Burn & Jessop Construction Company Limited, 27, R.N.Mukherjee Road, Kolkata-700 001 (W.B.).
d)	All costs and expenses incidental to preparation of the tender, discussion, conference, pre-tender site visit, pre-award discussion with BBJ shall be to the account of the tenderer and BBJ shall bear no liability whatsoever on such cost expenses.
04.	The bid documents should contain Proof of Tenderer's PAST EXPERIENCE pertaining to similar nature of job.
05.	Conditional tenders shall be straightway rejected and no additional clause will be entertained.
06.	The award of the order or rejection of the Tenderer's offer and/or cancellation of the tender will be made at the absolute discretion of BBJ. BBJ reserves the right to cancel or accept or reject any or all tender(s), whether lowest or otherwise, without assigning any reason(s) whatsoever thereof. A tenderer whose Tender is not accepted shall not be entitled to claim any cost, charges or expenses incidental to or incurred by him through or in connection with the preparation and submission of the Tender/Offer to BBJ. BBJ also reserves the absolute right to split up and award the requirement between two or more Tenderers.
07.	<u>CURRENCIES OF BID AND PAYMENT:</u> The Tenderer shall submit his price bid / offer in Indian Rupees and payment under this contract will be made in Indian Rupees.
08.	All duties, taxes, fees and other levies payable by the Sub-Contractor under the contract or any other cause shall be included in the quoted prices.
09.	Validity of Tender - 60 (Sixty) days from the date of opening of tender or for a further period if mutually accepted. BBJ reserves the right to ask for the extension of validity, if any.

SPECIAL CONDITION OF CONTRACT

1. SCOPE OF WORK:

Carrying out foundation work for Drill Machine, Milling Machine, Welding Fixtures and supply, spreading and compaction of stone ballast & morrum for service road & goliath crane Track at our Ganga Bridge Site as per instruction of engineer-In-Charge, Ganga Site, Sketch and BOQ as enclosed.

The Sub-contractor has to arrange **MOBILIZATION AND DEMOBILIZATION INCLUDING CLEANING OF WORK** site after completion of work.

2. DRAWING / SPECIFICATION

- a) The subject work has to be carried out as per BBJ's Sketch/relevant IS codes / specification.
- b) BBJ reserves the right to alter / modify the design / drawing / specification to suit their requirement.
- c) The materials as well as execution of the work shall be to the relevant Indian Standard specifications and Code of practice (Latest version of the specification / codes to be used).

3. QUANTITY VARIATION

- a) There may be quantity variation during actual execution of work.
- b) If due to change in design / drawing / specification, there is any increase / decrease in items / quantities up to any extent, payment will be made only for the actual work done with the same rate, terms and conditions of the original order on the Sub-Contractor by BBJ duly certified by the SITE-IN-CHARGE/BBJ, Ganga Bridge Site.

4. SUB-CONTRACTOR'S SCOPE

- a) The Sub-Contractor has to execute the above work with supply of all materials, consumables, labour, plant, tools & tackles, supervision, staging etc, all complete as per direction of BBJ.
- b) The Sub-Contractor has to arrange at his own cost all infrastructure facilities such as Labour/Supervision/ water/ electricity /POL/ labour accommodation for execution of the subject work and also the necessary consumables.

5. COMPLETION TIME

The entire job (as stated in our Scope of Work) has to be completed within **01 (One)** month from the date of LOI/Order.

6. EARNEST MONEY DEPOSIT:

Earnest Money Deposit of Rs. 5,000/= (Rupees five thousand only), in form of crossed D/D or pay order or Banker's cheque from a Nationalised Bank at Kolkata, drawn in favour of "The Braithwaite Burn & Jessop Construction Co. Ltd." to be submitted along with the tender. The Earnest money Deposit will be kept with BBJ which will be released within 30(thirty) days from the date completion of the work without any interest.

7. MAINTENANCE /DEFECT LAIBILITY PERIOD

One completion of the work to the satisfaction of BBJ, it will be taken over. From the date of taking over, the Sub-Contractor shall be responsible for the Maintenance of the work executed under his/their scope for a period of 06(six) months covering the defects attributable to the Sub-Contractor. The Sub-Contractor shall make good and remedy at his / their own expenses within such period as may be stipulated by BBJ, any defect which may be develop or may notice before expiry of this period.

8. PAYMENT TERMS

- a) 95% (ninety five percent) payment against each R/A Bill will be made within 15 days after submission of bill duly certified by the SITE-IN-CHARGE/BBJ, Ganga Bridge Site, Munger.
- b) Balance 5% (five percent) of the R/A Bill will be kept by BBJ as Security Deposit till Maintenance / Defect Liability period i.e. for a period of 06 (six) months from the date of completion and handing over the work to SITE-IN-CHARGE/BBJ, Ganga Bridge Site, Munger.
- c) Above 5% (five percent) of the R/A Bill will be released after successful completion of Maintenance / Defect Liability period

9. PRICE VARIATION

This is a fixed rate contract and no price variation / adjustment on any account is admissible during the tenure of the contract including extended time, if any granted by BBJ. PRICE SHALL REMAIN FIRM TILL COMPLETION FOR THE ENTIRE SCOPE OF WORK.

10. TAXES AND DUTIES

The Sub-Contractor's rate for the above work should be inclusive of all taxes and duties. Deduction of taxes and duties will be made at source as per prevailing statutory rules.

11. SUPERVISION & LABOUR

The Sub-Contractor will be responsible for providing adequate skilled labour and supervisory staff for timely execution of the work.

12.SAFETY & SECURITY MATERIAL/ PLANT/WORKMEN OF THE SUB-CONTRACTOR

The Sub-Contractor will be responsible for safety and security of material/plant & equipment, workmen deployed at site.

13. LABOUR LAWS AND STATUTORY OBLIGATION

The Sub-Contractor will observe within the quoted rate all Statutory Obligation during execution of the work including Minimum Wages Act, Act covering P.F., E.S.I and other Statutory benefits under Workmen's Compensation Act, Contract Labour Regulation & Abolition Act 1970 & subsequent amendments and other Acts in force in the State of Bihar. BBJ will have no responsibility in this regard.

14. TERMINATION OF CONTRACT

In case of failure to discharge the duties as per our requirement, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other Sub-Contractor /agencies. Cost incurred for the above shall be recovered from the contractor's bill and Security Deposit.

15. JURISDICTION OF COURT

The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.
