The specification with manufacturer's name of our required item and other terms and conditions related to our said NIT is given hereunder.

Tenders to be submitted in **TWO PARTS:-**

**(A). "TECHNO COMMERCIAL PART" -**

"TECHNO COMMERCIAL PART" SHOULD CONTAIN THE FOLLOWING DOCUMENTS WHICH TO BE SUBMITTED WITH THE OFFER, OTHER WISE NO OFFER WILL BE CONSIDERED AGAINST THIS NIT :-

- (a). The above manufacturers AND their valid authorized dealer(s) of respective manufacturer's is/are only entitled to submit their offer with latest relevant documents showing that they are the R.D.S.O. approved vendors/authorised dealers/suppliers for supply of Solid MIG/MAG Welding Filler Wire,Class I (**Part -I and Part-II Category both**);
  - (b). PART - I and PART-II category both of RDSO approved vendors are only entitled to submit their offer for supply of Copper coated solid 1.2mm dia M.S.Wire for GMAW;
  - (c). Copy of VAT/CST Registration Certificate;
  - (d). Copy of PAN Card;
  - (e). Copy of relevant documents/past experience certificate pertaining to similar nature of supply to other Govt. Organisations/PSUs or Reputed Companies;
  - (f). All the pages of the tender documents to be signed with company's seal by the tenderer;
  - (g). Brand and Manufacturer's name to be mentioned in offer clearly;
  - (h). Manufacturer's Test Certificate must be enclosed along with each consignment indicating shelf life/expiry date of the items as mentioned in BOQ.

BBJ reserves the right to cancel or accept or reject any or all tender(s), whether lowest or otherwise, without assigning any reason(s), whatsoever thereof. A tenderer whose Tender is not accepted shall not be entitled to claim any cost, charges or expenses incidental to or incurred by him through or in connection with the preparation and submission of the Tender/Offer to BBJ. BBJ also reserves the absolute right to split up and award the requirement between two or more Tenderers.

- (B). "PRICE PART" WILL BE OPENED BASED ON TECHNO COMMERCIALY ACCEPTABLE BIDDERS. PROPERLY FILLED UP BILL OF QUANTITIES DULY SEALED AND SIGNED TO BE PUT IN A SEALED ENVELOPE SUPER SCRIBING "TENDER NOTICE NO." AND "PRICE PART".
- (C). THE "TECHNO COMMERCIAL PART" AND "PRICE PART" TO BE PUT IN A SEALED ENVELOPE SUPER SCRIBING "TENDER NOTICE NO" TO BE SUBMITTED TO BBJ.
1. **Rate:-** The vendors must submit their rate strictly as per Bill of Quantities-**BOQ-1** of this tender document. The bidder must quote the Basic Price, Excise Duty, All other Taxes & Duties and Delivery Charges up to Wagon Care Centre, Mughalsarai. Per unit item as per BOQ-1. The price must be firm during the tenure of this supply/contract and no escalation or any account will be allowed. Entry Tax, if any, will be borne by BBJ.
  2. **Earnest Money Deposit :-** An amount of **Rs.50,000.00**(Rupees fifty thousand only) in form of account payee Demand Draft/Pay Order/Banker's Cheque in favour of "The Braithwaite Burn And Jessop Construction Company Limited" payable at Kolkata. Unsuccessful bidders will be refunded the Earnest Money Deposit amount after the award of the contract/order to the successful bidder. The EMD amount of successful bidder will be released within 30 days after completion of total supply/service without any interest subject to receipt of request from the successful bidder. The Units registered with National Small Industries Corporation(NSIC) are exempted from payment of EMD subject to :
    - (a). The NSIC Registration Certificate still remains valid up to the date of validity quotation
    - (b). The bid is accompanied with a copy of valid NSIC Registration Certificate.
    - (c). Photocopy of application for registration as NSIC for renewal of NSIC will not be acceptable. Such offers will be treated as offers received without EMD.
    - (d). For existing supplier(s), the EMD amount may be adjusted from their passed bill(s) amount subject to submission of their written declaration with their offer in connection with adjustment of their EMD amount.
  3. **Validity of Offer :** Your offer should be valid and firm for a period of 3(three) months from the date of opening of your offer.
  4. **Delivery Period & Delivery Place:-** Delivery to be made at our Mughalsarai Project Site(Wagon Care Centre, Mughalsarai) **with manufacturer's test certificate** in 2(two) phases (1<sup>st</sup> phase within 30 days and 2<sup>nd</sup> phase within 75 days from the date of LOI/Order whichever is earlier.
  5. **Variation of Quantities :-** If due to change in design/specification/requirement, if there is increase/decrease in items/quantities to any extent or both, BBJ reserves the right to make payment only for the actual quantity of supply with the same rate, terms & conditions of the original order on them.

6. **Payment** :- 100% within 30 days from the date of delivery and submission of bill with receipted challan with manufacturer's test certificate.
7. **Liquidated Damage** :- If you fail to complete supply as per our order within stipulated period, 0.5% of order value will be deducted from your bill for per week of delay subject to maximum of 5% of order value.
8. **Termination of Contract**:- If the supplier failure to complete the total work/supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours notice. Additional cost if incurred shall be recovered from the supplier's bill.
9. **JURISDICTION OF COURT**:  
The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes,if any, arising out of this agreement between the parties.
