- Digital Signature certificate (DSC) Each bidder must possess an appropriate Class-II or Class-III Digital Signature Certificate (DSC) for submission of tender, through CPPP as aforesaid. Otherwise, in case of non-availability, bidder is required to obtain the same from the approved service provider of the National In formation's Centre (NIC) on payment of requisite fees details of which are available at the Web Site stated in Clause 2 of Guideline to bidder for submission of the bid. DSC is given as a USB e-Token.

#### SPECIAL CONDITIONS OF CONTRACT

# 1. <u>DEFINATIONS AND INTERPRETATION</u>:

In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under:

- a) "BBJ" shall mean The Braithwaite Burn And Jessop Construction Company Limited having its Head Office at 27, R. N. Mukherjee Road, Kolkata 700 001.
- b) The "TENDER" shall mean the proposal submitted by the Tenderer/ Bidder/ Supplier/ Dealer/ Agency in response to BBJ's Notice of Invitation to this Tender Document.
- c) The "ORDER" shall mean a written Work Order issued by BBJ.
- d) The "TENDERER/BIDDER" shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBJ.

# 2. SCOPE OF WORK:

SUPPLY OF RAW MATERIAL FOR SITE (AS PER BOQ - 1)

Without GST registration in the name of the Tenderer, the Tender will be automatically cancelled.

#### 3. FIRM PRICE:

Your rate shall remain firm and shall not attract escalation due to any reason such as steel price hike whatsoever in pursuance of this contract for a period of six months from the date of order.

#### 4. PAYMENT TERMS:

Payment will be made within 30 days after delivery of materials along with co-related producers invoices & mill test certificates (MTC) and acceptance of the same. No payment will be made without receipt of co-related invoices & MTC by BBJ against materials delivered by supplier.

The EMD submitted with the bid will be kept with BBJ as Security Deposit and will be released 2 (two) months after completion of delivery without any interest.

#### 5. DELIVERY ADDRESS:

The Braithwaite Burn And Jessop Construction Co. Ltd. Heavy Plant Yard (HPY), P-82, Taratala Road, PO: Garden Reach Pin - 700 024

The delivery location as mentioned above may change to **Kharsia Bridge Site No. 17**, **Chhattisgarh** and/or **Panagarh**, **West Bengal** at the time of placement of order or during execution phase. The successful bidder has to execute the order as per the directives from BBJ.

#### 6. <u>TERMINATION:</u>

If the bidder fails to complete the total work/ supply as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours' notice. EMD/Security Deposit shall be forfeited. Additional cost if incurred shall be recovered from the bidder's bill.

# 7. LIQUIDATED DAMAGE:

If the successful bidder fail to complete the entire work within the stipulated period, **0.5%** (zero decimal five percent) of order value will be deducted from bill for per week delay or part thereof subject to a maximum of **5%** (five percent) of the total order value.

# 8. **INSPECTION AND TESTING:**

Producer's invoice and Mill's Test Certificates shall accompany with each items supplied. No payment will be released without Producer's invoice and Mill's Test Certificates

#### 9. **ROLLING MARGIN**:

+/- 2% or as specified in BIS codes as applicable.

## 10. TAXES AND DUTIES

The supplier shall be exclusively responsible for payment of all Taxes, Royalties etc. (except Goods and Service Tax) that may be levied from time to time according to the Laws & regulation now inforce & also hereafter to be imposed, increased or modified from time to time. Nothing will be payable extra by BBJ for any duties/taxes to be imposed on procurement of materials for execution of contract. In case Government imposes any new levy/tax after award of the work during the tenure of the contract, BBJ shall reimburse the same at actual on submission of documentary proof of payment subject to the satisfaction of BBJ that such new levy/tax is applicable to this contract.

#### 11. GOODS AND SERVICE TAX (GST)

- a) The quoted price shall be exclusive of Goods and Service Tax (GST). The GST as legally leviable & payable by the bidder under the provisions of applicable law / act shall be paid extra by BBJ as per bidder's bill. Bidder shall quote their rate after considering the input tax credit on their input materials and services. HSN code must be provided by the bidder in BOQ. b) The bidder shall get registered with the GST authorities and there registration certificate shall be submitted along the bid documents (techno commercial). Bid without GST number (in the name of the Bidder) shall be cancelled.
- c) At present no GST-TDS is applicable. If the same is applicable in future, deduction of GST-TDS at source would be enforced from the bills at the rates prescribed. The GST (i.e. SGST, CGST or IGST) amount shall be shown separately in invoice and also submit proper Tax Invoice as per section 31 of CGST Act, and Rule 46 of CGST Rules, 2017 to get Input Tax Credit by BBJ.
- **d)** Bidder shall raise their tax invoice in regular interval as per order terms & conditions and uploaded their supply invoice in GSTN Portal through GSTR-1 return within 10th of next month.

Mismatch in return of BBJ due to any reason attributable to bidder, the same shall be recovered from Bidder's bill.

#### 12. **INDEMNITY**

BBJ shall not be responsible for any loss or damage to any person or property that may be sustained in the course of transportation/movement of goods and all claims by any person/institution shall be settled by the supplier including loss or injury to any third party and from all liabilities resulting from negligence or default of supplier's employees or any other person in the course handling any transportation/movement of such goods.

#### 13. **GUARANTEE/WARRANTY:**

Any complaints on quality of material shall be promptly settled and replacement, if any, shall be done free of cost. In the event of rejection / lamination are found in plates, the supplier has to make free replacement of the same immediately at their cost and arrangement.

## 14. JURISDICTION OF COURT:

The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.

#### 15. NOTES TO BOQ:

- (a) While delivery of above items-nos. of pieces of particular item to be ensured
- (b) GST as applicable will be extra
- (c) Entry tax will be borne by BBJ during the contract period
- (d) BBJ reserves the right not to purchase any or all the items as per above BOQ and the supplier shall not have any claim against items not purchase by BBJ.
- (e) Quantity variation will be considered up to (+)/(-) 50%, for items to be purchased by BBJ
- (f) Road Permit will be arranged by BBJ
