## SPECIAL CONDITION OF CONTRACT

## 1. DEFINATIONS AND INTERPRETATION:

- 2. In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under :
  - a) "**BBJ**" shall mean The Braithwaite Burn And Jessop Construction Company Limited having its Head Office at 27, R. N. Mukherjee Road, Kolkata - 700 001.
  - b) The "**TENDER**" shall mean the proposal submitted by the Tenderer/Bidder in response to BBJ's Notice of Invitation to this Tender Document.
  - c) The "ORDER" shall mean a written Work Order issued by BBJ.
  - d) The "**TRANSPORTER**" shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBJ.

## 2. SCOPE OF WORK:

## 7. LIQUIDATED DAMAGE:
