1. DEFINATIONS AND INTERPRETATION:

In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under:

- a) "BBJ" shall mean THE BRAITHWAITE BURN & JESSOP CONSTRUCTION COMPANY LIMITED having its corporate office at 27, R. N. Mukherjee Road, Kolkata 700 001.
- b) The "TENDER" shall mean the proposal submitted by the Tenderer/ Bidder in response to BBJ's Notice of Invitation to this Tender Document.
- c) The "ORDER" shall mean a written Work Order issued by BBJ.
- d) The "PARTY" shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBJ.

2. SCOPE OF WORK:

- a) 125 Ton capacity or higher Tyre mounted Crane to be deployed at Chaibasa Site, Jharkhand on per RCC Girder handling rate basis (handling means lifting, removal and stacking/placing)
- **b)** The crane shall be deployed for handling of RCC girders (5 nos.) based on the availability of Power Block from Railway. Since, the block from Railway is not under our control, hence, deployment duration may vary according to the availability of traffic and power block from Railway.
