9) **Termination of Contract:-** If the supplier fails to complete the total Work/ supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full, as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days notice and then 48 hours notice. Additional cost, if incurred, shall be recovered from the supplier's bill.
