INSTRUCTION TO THE BIDDERS**1.0 REGISTRATION OF BIDDER**

Any bidder willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement system, through logging on to <https://eprocure.gov.in/eprocure>.

2.0 DIGITAL SIGNATURE CERTIFICATE (DSC)

Each bidder must possess an appropriate Class-II or Class-III Digital Signature Certificate (DSC) for submission of tender through CPPP as aforesaid. Otherwise, in case of non-availability, bidder is required to obtain the same from the approved service provider of the National Information's Centre (NIC) on payment of requisite fees details of which are available at the Web Site stated in Clause 2 of Guideline to bidder for submission of the bid. DSC is given as a USB e-Token.

3.0 SUBMISSION OF BID:

Bid to be submitted online through e-Procurement system of CPPP (<https://eprocure.gov.in/eprocure>).

Tender document to be digitally signed with Company's seal by the bidders. The rates in the appropriate space in the **BOQ** should be properly filled in. Tenders to be submitted in **two parts**:

A) **TECHNO-COMMERCIAL PART:** The Techno-Commercial part will consist of -

i) **PRE QUALIFICATION & ELIGIBILITY CRITERIA OF THE BIDDER**

Documentary evidence satisfying the Pre-Qualification Criteria (PQC) should be provided as part of Technical Bid. Any bidder who is not qualifying as per PQ Criteria will be rejected and price bid will not be opened.

a) The bidder company should be registered in India. Copy of Excise, VAT & CST (CST, as applicable), PAN, Service Tax Registration certificate, should be submitted.

b) **ELIGIBILITY CRITERIA**

Proof of supply of Structural Steel items to Government Organization/ PSUs within last 3 (three) years must be submitted with the bid.

B) **PRICE-PART -**

Properly filled in BILL OF QUANTITY (BOQ-1) duly digitally signed to be uploaded in Financial part.

2.0 Conditional tenders may be rejected and no additional clause will be entertained.

3.0 The successful bidder shall not sub-contract the selling and support procedure for the entire duration in BBJ.

4.0 Excise, VAT, CST (as applicable), PAN, Service Tax & VAT registration certificate should be submitted. **All duties, taxes, fees and other levies payable by the Bidder under this contract or any other cause shall be included in the quoted prices.**

5.0 **VALIDITY OF TENDER: – 90 (ninety) days** from the date of opening of tender or for a further period if mutually accepted.

SPECIAL CONDITION OF CONTRACT**1.0 DEFINITIONS AND INTERPRETATION:**

In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under:

- a) "**BBJ**" shall mean The Braithwaite Burn & Jessop Construction Company Limited having its registered Office at 27, R. N. Mukherjee Road, Kolkata-700 001.
- b) The "**TENDER**" shall mean the proposal submitted by the Tenderer/ Bidder/ Supplier/ Dealer/ Agency in response to BBJ's Notice of Invitation to this Tender Document.
- c) The "**ORDER**" shall mean a written Purchase Order issued by BBJ.

3.0 FIRM PRICE:

Your rate shall remain firm and shall not attract escalation due to any reason such as Steel price hike whatsoever in pursuance of this contract for a period of six months from the date of order.

Payment will be made after the delivery of materials along with co-related invoices & test certificates and acceptance of the same.

The EMD submitted with the bid will be kept with BBJ as initial security deposit and will be released 2(two) months after completion of delivery without any interest.

BBJ reserves the right to place order for entire quantity on lowest (L-1) bidder in the event of L-1 bidder is a MSME Company or BBJ reserves the right to split the tender quantity. In case of splitting decided, the same shall be in the ratio 70:30.

11.0 BBJ shall not be responsible for any loss or damage to any person or property that may be sustained in the course of transportation/ movement of goods and all claims by any person/ institution shall be settled by the supplier including loss or injury to any third party and from all liabilities resulting from negligence or default of supplier's employees or any other person in the course handling any transportation/ movement of such goods

12.0 Risk Purchase:

In the event of failure or delayed supplies, the order may be cancelled and the BBJ reserves the right to get the job done by other Agency/Agencies as per the order on Risk Purchase basis and shall recover the extra cost thereof, if incurred from the supplier. SD/ PBG of the defaulting firm may also be forfeited.

13.0 Guarantee/ Warranty:

Any complaints on quality of material shall be promptly settled and replacement if any shall be done free of cost. In the event rejection / lamination are found in plates, the supplier has to make free replacement of the same immediately at their cost and arrangement.
