<b>02.</b>	<b><u>LANGUAGE</u></b> Bids and all accompanying document shall be in English. In case any accompanying documents are in other language, it shall be accompanied by an English translation. The English version shall prevail in matter of interpretation.
<b>03.</b>	<b><u>SUBMISSION OF TENDER</u></b>
<b>a)</b>	The Tender shall be signed by the person legally authorised to enter into commitment on behalf of the Tenderer.
