01.	"SUBMISSION OF TENDER" shall be read in conjunction with General Commercial Terms and conditions and any other documents forming part of this Tender Document wherever the context so requires. Notwithstanding the sub-division of the documents into the separate section, every part of each shall be deemed to be supplementary to and complementary to every other part and shall be read with the document so far as it may be practicable to do so wherever it is mentioned that the Sub-Contractor shall perform certain work or provide certain facilities, it is understood that the Sub-Contractor shall do so at their cost.
02.	<u>LANGUAGE</u> Bids and all accompanying document shall be in English. In case any accompanying documents are in other language, it shall be accompanied by an English translation. The English version shall prevail in matter of interpretation.
03.	<u>SUBMISSION OF TENDER</u>
a)	The Tender shall be signed by the person legally authorised to enter into commitment on behalf of the Tenderer.
b)	All the pages of the tender document to be signed with Company's seal by the Tenderer. The rates in the appropriate space in the BILL OF QUANTITIES should be properly filled, both in figures and words. No overwriting, using of correction fluid will be allowed. Any correction will be done by scoring out the incorrect entry and inserting the new entry in a legible manner. Both the correction and new entry to be signed and sealed with Company's seal. In the event of any difference between figure & words of the quoted rates, the rate in word shall be considered for evaluating the tender.
c)	The tender is to be submitted in a sealed cover and superscribed with Tender Reference, Due Date marked for the Deputy General Manager(P-V), The Braithwaite Burn & Jessop Construction Company Limited, 27, R.N.Mukherjee Road, Kolkata-700 001 (W.B.).
d)	All costs and expenses incidental to preparation of the tender, discussion, conference, pre-tender site visit, pre-award discussion with BBJ shall be to the account of the tenderer and BBJ shall bear no liability whatsoever on such cost expenses.
e)	Tenderers will visit the site and satisfy himself of the work before submission of Tender.
04.	Conditional tenders shall be straightway rejected and no additional clause will be entertained.
05.	The award of the order or rejection of the Tenderer's offer and/or cancellation of the tender will be made at the absolute discretion of BBJ. BBJ reserves the right to cancel or accept or reject any or all tender(s), whether lowest or otherwise, without assigning any reason(s) whatsoever thereof. A tenderer

	whose Tender is not accepted shall not be entitled to claim any cost, charges or expenses incidental to or incurred by him through or in connection with the preparation and submission of the Tender/Offer to BBJ. BBJ also reserves the absolute right to split up and award the requirement between two or more Tenderers.
06.	<u>CURRENCIES OF BID AND PAYMENT:</u> The Tenderer shall submit his price bid / offer in Indian Rupees and payment under this contract will be made in Indian Rupees.
07.	All duties, taxes, fees and other levies payable by the Sub-Contractor under the contract or any other cause shall be included in the quoted prices.
08.	Validity of Tender – 90 (Ninety) days from the date of opening of tender or for a further period if mutually accepted. BBJ reserves the right to ask for the extension of validity, if any,

SPECIAL CONDITION OF CONTRACT

1. DEFINITIONS AND INTERPRETATION:

In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under

- a) "BBJ" shall mean The Braithwaite Burn & Jessop Construction Company Limited having its registered Office at 27, R.N.Mukherjee Road, Kolkata-700 001.
- b) The "TENDER" shall mean the proposal submitted by the Tenderer/ Bidder in response to BBJ's Notice of Invitation to this Tender Document.
- c) The "ORDER" shall mean a written Work Order issued by BBJ.
- d) The "SUB-CONTRACTOR" shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBJ.
- e) "PROJECT SITE / SITE " mean site of work at BBJ Chaibasa Project Site, Jharkhand.

2. SCOPE OF WORK:

- (a). The Agency should provide a 380 KVA Diesel Generator Set on daily hire charges basis in good working condition having valid documents with Diesel Generator Set Operator.
- (b). During contract period, the 380 KVA capacity hired Diesel Generator Set will work as per direction of Site-In-Charge/BBJ, Chaibasa Project Site, Jharkhand
- (c). The Agency will be responsible for all maintenance, all repairs (major & minor), carrying cost (to and fro) and labour charges for their hired Diesel Generator Set.
- (d). Fuel & Lubricants are to be supplied by BBJ at free of cost during the contract period.
- (e). Duty of hired D.G.Set Operator will be valid for 12 hours each day.
- (f). BBJ will provide Road Permit for incoming materials.
- (g). BBJ will provide Road Permit for outgoing materials subject to deduction at source i.e. @5% on value of materials.

3. PERIOD OF CONTRACT:-  
The deployment of 380 KVA capacity hired Diesel Generator Set will be required for maximum 05(Five) working days. However, the duration of contract may vary as per requirement of our Chaibasa Project Site, Jharkhand.
4. FIRM PRICE :-  
Your rate shall remain firm and shall not attract escalation due to any reason during the contract period. The rate for daily hire charges of 380 KVA capacity Diesel Generator Set will inclusive of all taxes & duties, all repairs (major & minor), carrying cost (to and fro) and labour charges.
5. PAYMENT TERMS:  
within 30 days after receipt of clear bill subject to certification of the respective Site In-charge.
6. TERMINATION OF CONTRACT:  
In case of failure to discharge the duties/supply as per our requirement, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other Sub-Contractor /agencies. Cost incurred for the above shall be recovered from the contractor's bill and Security Deposit.
7. JURISDICTION OF COURT:  
The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.
