3. **Validity of Rate** : Your quoted rate should be valid and firm for a period of 3(three) months from the date of opening of your offer. Entry Tax, if any, will be borne by BBUNL/BBJ.
4. **Delivery Period & Delivery Place** :- Delivery to be made at our Heavy Plant Yard, P-82 Taratala Road,Garden Reach,Kolkata-700 024 **within 15 days** from the date of LOI/Order.
5. **Manufactuer's Test Certificate and Guarantee/Waranty Certificate to be submitted at the time of delivery.**
6. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan alongwith Manufacturer's Test Certificate and Warranty/Guarantee Certificate.
7. **Earnest Money Deposit** :- An amount of **Rs.5,000.00**(Rupees five thousand only) to be submitted with individual offer, as EMD amount in form of account payee Demand Draft/Pay Order/Banker's Cheque in favour of "The Braithwaite Burn And Jessop Construction Company Limited", payable at Kolkata.
