Shifting of 1 No. 1.5 Ton Split AC from 1st floor to Ground floor at our Alipure Office.

b) The above job includes on-site comprehensive Labour Warranty/On-site comprehensive spares warranty as applicable.

c) The Contract will cover complete repairing/ procurement of spares from respective manufacturers and replacement of the same.

d) Prompt and efficient service on part of the Agency in respect of the above is necessary.
