Dear Sir(s),

Sealed tenders are invited from the reputed party in connection with procurement of different type of networking equipments and other hardwares related to new network connection of such computers which are not covered under our existing network connectivity. The description our required hardwares and networking equipments with other terms & conditions are given hereunder.

- (a). Switch** :- 2(Two) nos- 24 Port, 10/100/1000 MBPS, unmanaged, rack mount, plug and play with high band with switch (Make:- D-Link/TP Link/Netgear/CISCO) with rack mount and other kits required for networking. Both IP4 & IPS supported switches are preferred. The switch should support Windows XP, 7, 8, 10, Windows Server 2008 and Linux operating system.

**(b). Patch Panel** :- 2(two) Rack mountable 24 ports CAT5/CAT6e patch panel is required for above two unmanaged switch including rack mount and other kits. The patch panels are required to be compatible with above switches. For monitoring, interconnecting and testing circuits in a convenient, flexible manner. Patch panel will be connected to the switch via CAP5 / CAT6e patch cable.

**(c). Network Cable** :- CAT5/CAT6e RJ45 Ethernet network cable with 1000 MBPS speed for gigabit LAN - 305 Meter bundle per box.

**(d). RJ45 Connector** :- 50 (Fifty) nos. pack, CAT5, CAT5E, CAT6, CAT6E RJ45 Ethernet crimp connectors LAN adapter is required for gigabit wired network. The gold plated connector should support above network and sytem environment.

**(e). Patch Cbale** :- 75 (seventy five) nos. with 1 meter length and 25 (twenty five) nos with 3 meter length, total 100 nos. of CAT5 / CAT6e patch cable is required for 2(two) nos. - 24 port switches. Machine crimped patch cables is/are required for connect both ends (i.e. to connect patch panel to switch and desktop PC to I/O Box).

- (f). **I/O Box with SMB + Face Plate (CAT5/CAT6e)** :- Initially 24 (twenty four) nos. required for provide connection to existing employees, from 2(two) nos.- 24 port switches. I/O Box will be used at the end-user PC side to ensure firm and tight physical connectivity of the terminated cables at the user and ensuring consistent and quality connectivity.
- (g). **USB Drive / Pen Drive (64 GB)** :- 1(one) ns- USB/Pen Drive with 64 GB storage capacity and USB 2.0, 3.0, 3.1 interface for desktop computers and laptops. The drive should support Windows XP, 7, 8, 10, Windows Server 2008 and Linux operating system environment. "KINGSTON" / "HP" / "SANDISK" make drivers and preferred.
2. **Installation/Job work part as follows, which will be charged as extra :-**
- (i). Labour Charges for cable layout including PVC pipe/casing to be mentioned per meter basis;
  - (ii). Rate of I/O fixing, connection termination to be mentioned per unit basis;
  - (iii), Rate of Patch Panel termination and termination to be mentioned per piece basis;
  - (iv). Rate of Switch Set up to be mentioned per piece basis.
3. **Rate** :- Your quoted rate should be inclusive of all taxes & duties.
4. **Validity of Rate** : Your quoted rate should be valid and firm for a period of 3(three) months from the date of opening of your offer.
5. **Place of work :-** At BBJ Registered Office, 27 R.N.Mukherjee Road, Kolkata-700 001.
6. **Delivery & Installation/ Completion Period:** - Within 30 days from the date of LOI/ORDER which ever is earlier.
7. **Payment** :- Within 30 days from the date of delivery/installation/completion of work and submission of bill with receipted challan subject to certification of the respective department.
8. **Earnest Money Deposit** :- An amount of **Rs.5,000.00**(Rupees five thousand only) to be submitted with individual offer, as EMD amount in form of "**Demand Draft**"/"**Pay Order**"/"**Banker's Cheque**" inf avour of "The Braithwaite Burn And Jessop Construction Company Limited", payable at Kolkata. Unsuccessful bidders will be refunded the Earnest Money Deposit amount after the award of the contract/order to the successful bidder. The EMD amount of successful bidder will be released within 30 days after completion of total supply/service/installation/work without any interest subject to receipt of written request from the successful bidder. The Units registered with National Small Industries Corporation(NSIC) are exempted from payment of EMD subject to :
- (a). The NSIC Registration Certificate till remains valid up to the date of validity quotation
  - (b). The bid is accompanied with a copy of valid NSIC Registration Certificate.

- (c). Photocopy of application for registration as NSIC for renewal of NSIC will not be acceptable. Such offers will be treated as offers received without EMD.
  - (d). For existing supplier(s), the EMD amount may be adjusted from their passed bill(s) amount, subject to submission of their written declaration with their offer in connection with adjustment of their EMD amount from their outstanding bills if any.
9. **Termination of Contract**:- If the supplier/party failure to complete the total work/supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours notice. Additional cost if incurred shall be recovered from the supplier's bill.
10. **JURISDICTION OF COURT**:  
The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.
11. **Last Date of Submission** :- Your sealed quotation must reach to our Head Office on or before **9<sup>th</sup> November,2016 by 5.00 p.m.**
