4. **Delivery Place** :- At BBJ Heavy Plant Yard, P-82 Taratala Road, Garden Reach, Kolkata-700 024 **OR** BBJ Ganga Bridge Site, Munger (Bihar).
5. **Delivery Period**: - Within 15 days from the date of LOI/Order whichever is earlier.
6. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan.
7. **Liquidated Damage** :- If you fail to complete supply as per our order within stipulated period, 0.5% of order value will be deducted from your bill for per week of delay subject to maximum of 5% of order value.
