**INSTRUCTION TO BIDDERS**

**1.0 SUBMISSION OF TENDER**

Tenders shall be read in conjunction with General Commercial Terms & Conditions and any other documents forming part of this tender document wherever the context so requires. Notwithstanding the sub-division of the documents into the separate section, every part of each shall be deemed to be supplementary to and complementary to every other part AND SHALL be read with the document so far as it may be practicable to do so wherever it is mentioned that the Sub-Contractor shall perform certain work or provide certain facilities, it is understood that the Sub-Contractor shall do so at their cost.

**2.0 LANGUAGE**

Bids and all accompanying document shall be in English. In case any accompanying documents are in other language, it shall be accompanied by an English translation The English version shall prevail in matter of interpretation.

**3.0 ELIGIBILITY CRITERIA**

**3.1 Technical Criteria:**

Vendors should have experience of having successfully completed similar works (defined below) during last seven financial years ending on 31<sup>st</sup> March, 2016 fulfilling any of the following criteria;

- (a) 03 (three) similar works costing not less than **Rs.76.00 lac** each OR executed 03 (three) similar Fabrication works involving welding not less than **500MT** against each such job.  
OR
- (b) 02 (two) similar works each costing not less than **Rs.95.00 lac** each OR executed 02 (two) similar Fabrication works involving welding not less than **625 MT** against each such job.  
OR
- (c) 01 (one) similar work each costing not less than **Rs.152.00 lac** each OR executed 01 (one) similar Fabrication works involving welding not less than **1000 MT** against each such job.

The term similar works shall mean works of following nature:

**Experience in structural steel fabrication involving welding preferably in Railway Wagon repair.**

Besides, following additional conditions are applicable:

- Time period [i.e. start date & end date] for execution of each qualifying work [against Clause no. 3.1 (a/b/c)] must be indicated by the bidder. Documentary evidence in support of the same shall be submitted.

**INSTRUCTION TO BIDDERS**

- The bidder should submit supporting document with respect to the jobs carried out as a proof of experience duly inspected by renowned inspection agencies like RDSO, RITES, Zonal Railways, PSUs, Govt. Deptt.
- The job may be carried out either in registered wagon builder's premises or any other premises duly inspected by RDSO/ RITES/ Railways own inspection as a sub-contractor, the bidder shall submit relevant traceable documents in support of such experience/ claim. However, manufacturers of different wagon components which generally bought out items shall not be considered as similar works.

**3.2 Financial Criteria:**

Vendors should have average annual turnover of **Rs.57.00 lac** during last 3 (three) financial year ending 31<sup>st</sup> March, 2016. Bidder must have earned net profit in any of the last 3 (three) financial years ending 31<sup>st</sup> March, 2016 and should have positive net worth as on 31<sup>st</sup> March, 2016.

Audited Balance Sheet and Profit & Loss accounts for last 3 (three) financial year ending 31<sup>st</sup> March, 2016 need to be submitted in support of above requirement.

- 3.3 Earnest Money Deposit (EMD): Deposit of Earnest Money amounting to **Rs.2,50,000/-** (Rupees twenty-five lac only) may be made in the form of Pay Order/ Demand Draft drawn in favour of "The Braithwaite Burn And Jessop Construction Company Ltd.", payable at Kolkata and shall be valid for a period of 90 (ninety days) from the date of opening of the tender. In case the tenderer withdraws their offer within validity period of their offer or fails to undertake the contract after acceptance of their tender, the full amount of EMD shall be forfeited. Tender(s) submitted without EMD or with less deposit of EMD than specified in the Techno-Commercial bid shall be rejected.

EMD will be converted to Security Deposit and will be kept till completion of Defect Liability Period for the successful bidder. For unsuccessful bidder, EMD shall be refunded immediately after finalization of the tender. EMD shall be interest free.

- 3.4 Any firm who is financially qualified but does not qualify technically may enter into a TECHNICAL TIE-UP/ MOU with another firm having technical expertise and past experience of doing similar work through an agreement. The partners of the said MOU to be jointly or individually responsible for fulfilment of the contractual obligation.

**4.0 DISTRIBUTION OF ORDER**

The order shall be distributed in the following manner;

- L1/L2/L3/L4 Bidder – Each bidder shall get **25% (twenty-five percent)** of the job quantity as mentioned in "BOQ-1".

**INSTRUCTION TO BIDDERS**

In such scenario L2/L3/L4 bidder shall have to accept the price quoted & accepted by L1 bidder. In case L2/L3/L4 bidder does not accept the L1 price, the offer shall be passed on to the next bidder who will accept the L1 price.

**5.0 SUBMISSION OF BID**

- 5.1 All the pages of the Tender document to be signed with Company's seal by the bidders. The rates in the appropriate space in the BILL OF QUANTITY of the tender should be properly filled in both in figures and words. No overwriting, use of correction fluid will be allowed. Any correction will be done by scoring out the incorrect entry and inserting the new entry in a legible manner. Both the correction and new entry to be signed and sealed with Company's seal. In the event of any difference between figure & words of the quoted rates, the rate in word shall be considered for evaluating the tender.
- 5.2 The Tender shall be signed by the person legally authorized to enter into commitment on behalf of the tenderer. All the pages of the Tender Document to be signed with Company's seal by the tenderer. The rates in the appropriate space in the BILL OF QUANTITIES should be properly filled, both in figures and words. No overwriting, use of correction fluid will be allowed. Any correction will be done by scoring out the incorrect entry and inserting the new entry in a legible manner. Both the correction and new entry to be signed and sealed with company's seal. In the event of any difference between figure & words of the quoted rates, the rate in word shall be considered for evaluating the tender. Tenders to be submitted in two parts as per following:

**5.3 TECHNO-COMMERCIAL PART:**

The Techno-Commercial bid should contain the following:

- 5.3.1 List of work completed in the last seven financial years giving description of work, organization for whom executed, approximate value of contract at the time of award, date of award and date of scheduled completion of work, date of actual start, actual completion and final value of contract should also be given.
- 5.3.2 List of works on hand indicating description of work, contract value, approximate value of balance work yet to be done and date of award.
- 5.3.3 In case of items (5.3.1) & (5.3.2) above, supportive documents/ experience certificates pertaining to job/ similar nature of job from the organizations with whom they worked/ are working should be enclosed.

Note: Certificates from private individuals for whom such works are executed/ being executed shall not be accepted. Certificates only from Indian Railways, Central/ State Government/ Union Territories Organizations/ PSUs/ Corporations shall be accepted.

**INSTRUCTION TO BIDDERS**

- 5.3.4 List of Plant & Machinery available on hand (Own) and proposed to be inducted (Own & hired to be given separately) for the subject work.
- 5.3.5 Details showing that he has an established proper supervisory control organization to ensure that there is adequate control at all stages of execution of the contract.
- 5.3.6 Signed copy of PAN and VAT registration certificates should be furnished along with the Techno-commercial bid.
- 5.3.7 License regarding engagement of workers in the contract works from Labour Department or to submit undertaking.
- 5.3.8 Signed copy of P.F. & ESI Registration Certificate.
- 5.3.9 Company's audited Balance Sheet for last 3 (three) years.
- 5.3.10 Earnest Money Deposit (EMD) of Rs.2,50,000/- (Rupees two lac fifty thousand only) in the form of Demand Draft/ Pay Order from Nationalised Bank at Kolkata, drawn in favour of "The Braithwaite Burn and Jessop Construction Co. Ltd." and payable at Kolkata. For the case of successful bidder, this EMD will be converted to Security Deposit till completion of Defect Liability Period.
- 5.3.11 The above documents are to be put in a sealed envelope superscribing "TENDER NOTICE NO. AND TECHNO-COMMERCIAL PART" to be submitted to BBJ.

**5.4 PRICE PART**

The tender documents issued by the bidders duly signed and sealed in each page along with properly filled up BILL OF QUANTITY to be put in a sealed envelope superscribing "TENDER NOTICE NO." and "PRICE PART".

- 5.5 The above two sealed envelope i.e. 'TECHNO-COMMERCIAL PART' and 'PRICE-PART' shall be put in a sealed envelope superscribing "TENDER NOTICE NO./NAME OF WORK" to be submitted to BBJ Please refer CHECK LIST (Annexure-III) in this regard.

**6.0 EXEMPTION FOR MICRO & SMALL ENTERPRISES:**

- i) Micro & Small Enterprises units registered with National Small Industries Corporation (NSIC) will be given following benefits:
- a) Issue of Tender set free of cost
  - b) Exemption from payment of Earnest Money Deposit
- ii) Firms registered with NSIC under its "Single Point Registration Scheme".

(Exemption will apply only to items/ services indicated under description of work/ supplies/ services & value up to which the firms are registered with NSIC).

**INSTRUCTION TO BIDDERS**

To obtain above benefits, firms should necessarily submit signed copy of valid Registration Certificate issued by NSIC. Firms who are in the process of obtaining NSIC Registration will not be considered for the benefits.

- 7.0** All costs and expenses incidental to preparation of the tender, discussion, conference, pre-award discussion with BBJ shall be to the account of the Tenderer and BBJ shall bear no liability whatsoever on such cost expenses.
- 8.0** **Conditional tenders may be rejected and no additional clause will be entertained.**
- 9.0** The award of the order or rejection of the Tenderer's offer and/or cancellation of the tender will be made at the absolute discretion of BBJ. BBJ reserves the right to cancel or accept or reject any or all tender(s), whether lowest or otherwise, without assigning any reason(s) whatsoever thereof. A tenderer, whose tender is not accepted shall not be entitled to claim any cost, charges or expenses incidental to or incurred by him through or in connection with the preparation and submission of the Tender/Offer to BBJ.

**10.0 CURRENCIES OF BID AND PAYMENT**

The tenderer shall submit his price bid/ offer in Indian Rupees and payment under this contract will be made in Indian Rupees.

- 11.0** All duties, taxes, fees and other levies payable by the sub-contractor under the contract or any other cause shall be included in the quoted prices. However, all the applicable tax component(s) should be clearly mentioned by the sub-contractor in the quotation (both techno-commercial & price bid).

**12.0 VALIDITY OF TENDER**

**90 (NINETY) days** from the date of opening of tender or for a further period if mutually accepted. BBJ reserves the right to ask for the extension of validity, if any.

**13.0 ORDER OF PRIORITY OF CONTRACT DOCUMENTS**

Where there is any conflict between the various documents in the contract, the following order of priority shall be followed i.e. a document appearing earlier shall override the document appearing subsequently:

- 1) Work order

**14.0 IMPORTANT NOTES;**

BBJ reserves the right to:

- 14.1 Accept or reject any bid received at its discretion without assigning any reasons whatsoever.
- 14.2 Increase/ decrease/ alter the job description/ scope of work with corresponding change in the value of contract.
- 14.3 Postpone or extend the above mentioned date, split and distribute the work among more than one bidder without assigning any reason what so ever.
- 14.4 May ask for further qualification during techno commercial scrutiny of bids received.
- 14.5 BBJ shall not be responsible for any delay, loss, damage for bids sent by post.
- 14.6 BBJ shall not be liable for any expenses incurred by bidder in preparation of bid irrespective of whether it is accepted or not.
- 14.7 Canvassing i.e. soliciting favour, seeking advantage etc. in any form is strictly prohibited and any bidder found to have engaged in canvassing shall be liable to have his bid rejected summarily.
- 14.8 If the bidder deliberately gives any wrong information in his tender to create circumstances for the acceptance to his bid, BBJ reserves the right to reject such application.



**SCOPE OF WORKS**

**1.0 NAME OF WORK:**

**Engagement of contractor(s) for repair of Railway Wagon at Railway's Wagon Care Centre, Mughalsarai under East Central Railway, Hajipur.**

The scope described hereunder is only indicative in nature and shall be deemed to be inclusive of all items to be executed for successful completion of the work as per Specifications and Drawings.

**NOTE:**

- a) The RDSO drawing series as mentioned in this tender document may be changed by East Central Railway, Hajipur. In that case the fabrication agency shall be bound to carry out the fabrication work as per the said changed RDSO drawing series without any other claim to BBJ on account of such changes.
- b) Target dates indicated above may be modified by BBJ as per requirement of East Central Railway, Hajipur and no claim will be entertained on this account.

**2.0 PLACE OF WORK**

The works shall be carried out at designated site location at Railway's Wagon Care Centre, Mughalsarai under East Central Railway, Hajipur.

**3.0 MANPOWER:**

The Agency should deploy sufficient number of man power for repairing at least 10 wagons or more per day.

**4.0 SCOPE OF WORK:**

- a. Supply of all labours required for receiving, carrying, returning all items from/to BBJ store/ designated places, for carrying out all the works required for preparing of Railway Wagons like cutting, welding, fabricating, fixing etc.
- b. Preparation and maintenance of all records.
- c. Arranging inspections, obtaining IC from the Railway.

**5.0 RESOURCES TO BE DEPLOYED/ARRANGED BY CONTRACTOR:**

- a. All tools, plants, machineries, small handling equipment required for the work.
- b. Welding machines with accessories, Bolts, Gas Cutting machines including Pug Cutter, Grinder.
- c. Safety gears for workers.

**SCOPE OF WORKS**

**6.0 FACILITIES TO BE PROVIDED BY BBJ:**

- (i) Crane for lifting of heavy items will be supplied by BBJ.
- (ii) Consumables like cutting gasses, welding electrodes/ wires/ CO2/ O2/ LPG, different components of Railway Wagons, paint and steel required for the work will be supplied by BBJ. However, the said items are subject to reconciliation.
- (iii) Power will be provided free of cost by BBJ up to one tapping point and further distribution to be done by the party.
- (iv) Compressed Air will be supplied free of cost.

**7.0 GENERAL WORK PROCEDURE:**

Repair will be done as per pre-inspection sheet jointly prepared by authorized representative of Sr.DME/MGS and representative of the contractor. This will include identification of damages to Side panel, End panel, Floor, Door, Door mediator etc.

**A. Work of repair shall broadly include:**

- (i) Gas cutting and removal of the damaged parts.
- (ii) Surface preparation, including straightening for proper fitment and removal of rust by wire brushing of the surface on which welding is to be done.
- (iii) Cutting of MS sheets to pre-determined sizes.
- (iv) Fixing the patch by means of tack welding followed by continuous welding (either lap or butt as the case may be) of the patch by MMAW (Manual Metal Arc Welding). The weld should be free from visible defects, such as discontinuities, cracks, undercut etc.
- (v) Chipping of slag after welding and cleaning with wire brush.
- (vi) Painting of the repaired area with coat of red-oxide primer.
- (vii) Marking on repaired patches as per "Marking diagram" RDSO Drawing No. WD- 80007-S/21.
- (viii) Riveting operation, as required.
- (ix) Collection of scrap generated in work place and stacking the same at nominated place.
- (x) Any other miscellaneous welding works as required to make wagon loadable.
- (xi) In general, instructions for fabrication/ repair contained in RDSO Specification No. G-72 Rev.-3 should be followed.
- (xii) Specification of electrode should conform to IRSM 28/12 IS 814 2004 IS/AWS Code 4112
- (xiii) Supply items as detailed in schedule below will have to be got inspected by inspecting authority.
- (xiv) Quantity supplied for each items should match with progress of work and actual consumption. So that overstocking as well as issue of security of material is minimised. No payment shall be made against supply of any items.
- (xv) The Panel patching and other repairs will be carried out as per instruction of authorized representative of Sr.DME(C&W)/MGS.

**SCOPE OF WORKS**

**B. Welding Procedure:**

- (i) In general, instructions for welding, edge preparation, procedure of welding etc. contained in RDSO Specification No. G-72 Rev.-3 should be followed.
- (ii) Earthing of wagons trolley should be ensured before starting welding work. Method of earthing is as under:  
If any welding work is done after assembly of wagons proper earthing shall be ensured so that electric current does not pass through the bearings. The earthing should be done very close to welding area and the earthing wire should be tightly secured at both ends. Alternatively, the earthing can be done with an earthing wire/strip running parallel to the track instead of earthing with rails. If wagons are not properly earthed the current passing through the bearings will cause arcing in between the rollers and the race ways leading to failure. All the earthing ports may be properly grounded through periodically calibrated earth pits. Earthing wires and conductors shall be arranged by contractor itself.
- (iii) Details of the edge preparation for welding shall be in accordance with IS:9595-1980 "Recommendations for Metal Arc Welding of Carbon Manganese Steels".
- (iv) Only those electrodes and wire-flux combinations which have been approved by RDSO shall be used for welding.
- (v) All welds shall be homogenous and show physical properties similar to those of parent metal. Finished welds shall be perfectly free from all defects such as porosity, burnt metal, inclusions etc. and shall present as smooth appearance.
- (vi) Welded joints defect specially due to the use of equipment and /or filler material shall not be accepted. After welding the welded parts or assemblies should correspond to the dimensions required as per mentioned in drawings.

**8.0 DETAILED WORK PROCEDURE (ITEM WISE):**

**(A) Repair of corroded, broken & cracked wall portion of wagons by replacement with new 5mm thick patches.**

- (i) Removing the damaged side wall/ End wall/ribs and preparing the work area for fixing the new Patch of suitable size.
- (ii) Cutting and fixing the new side wall/ End wall/ribs patch on the wagon by tack welding.
- (iii) Continuous lap welding of the side wall/ End wall/ribs patch on both side.
- (iv) Painting and Marking as per "Marking diagram" of the repaired area with single coat of red-oxide primer.
- (v) Component arrangement should confirm to RDSO Drawing No. WD 80007-S-05 & 06 And BOXN/Sketch./MGS/02
- (vi) Supply of consumables like electrode, cutting gas, electricity etc. for carrying out the repair work.
- (vii) Collection and disposal of scrap at nominated place.

**SOW-4**

**SCOPE OF WORKS**

- (B) Repair of corroded, broken & cracked floor portion and covering plate of top coping of wagons by replacement with new 6mm thick patches**
- (i) Removing the damaged floor panel/covering plate for top coping and preparing the work area for fixing the new Patch of suitable size.
  - (ii) Cutting and fixing the new floor panel/covering plate patches on the wagon by tack welding.
  - (ii) Continuous lap welding of the floor/covering plate for top coping on the top.
  - (iv) Painting and Marking as per "Marking diagram" of the repaired area with single coat of red-oxide primer.
  - (v) Component arrangement should confirm to RDSO Drawing No. WD 80007-S-04 & 05 And BOXN/Sketch./MGS/01
  - (vi) Supply of consumables like electrode, cutting gas, electricity etc. for carrying out the repair work
  - (vii) Collection and disposal of scrap at nominated place.
- (C) Repair of corroded, broken & cracked Channel of ISMC-100 at floor stinger, side middle coping, Top Coping and doorway stiffener:**
- (i) Cutting the channel ISMC-100 of required length.
  - (ii) Fixing the ISMC – 100 as required as per Drg. No: WD-80007-S-05 & WDS0007-S-04
  - (iii) Complete welding of the coupling bar (ISMC – 100)
  - (iii) Attending any other unforeseen and exigency repairs.
  - (iv) Welding of covering plate along with replaced top coping as per Drg. No: WD-80007-S-05
  - (v) Attending Painting and stencilling on the repaired portions.
  - (vi) Supply of consumables like electrode, cutting gas, electricity etc. for carrying out the repair work
  - (vii) Collection and disposal of scrap at nominated place.
- (D) Repair of corroded, broken & cracked crib angles (ISA 50X50X6) of wagon body**
- (i) Cutting the angles of required length.
  - (ii) Fixing the angles as required as per Drg. No: WD-80007-S-14 & WD-S0007-S-04
  - (iii) Attending any other unforeseen and exigency repairs.
  - (iv) Attending Painting and stencilling on the repaired portions.
  - (v) Supply of consumables like electrode, cutting gas, electricity etc. for carrying out the repair work
  - (vi) Collection and disposal of scrap at nominated place.

**SPECIAL CONDITION OF THE CONTRACT**

**1.0 WORKMANSHIP:**

The workmanship for the fabrication operations, Testing, Material shifting etc. shall be closely monitored by The Agency's supervisory staff as per the specification and as directed by Engineer/ Engineer in-charge of BBJ/ RAILWAY and/or RITES and/or any other authorised agency of RAILWAY. Any work done by the Agency, which is found unsatisfactory, should be rectified/ redone as per the instructions, immediately after notifying to the Agency. If the Agency fails to do so and the same is done by RAILWAY and RAILWAY deducts the cost pertaining to the same from BBJ, then BBJ will also recover the same amount from any due payment of the Agency.

Any rejection on grounds of quality shall be re-done at the Agency's cost.

**2.0 TESTING OF WELDING**

Type of testing & frequency of testing will be as per the latest version of approved QAP/technical specification and the Agency will bear all the cost towards testing. The testing & inspection percentage (for example RT/UT percentage) can vary to any extent. BBJ/ RAILWAY decision will be final and binding to all the parties. In case, welding fails to meet the accepting criteria of the testing, the Agency will do the rework on his cost and risk.

**3.0 QUANTITY OF WORK TO EXECUTE**

Total quantity of work to be executed shall be distributed evenly among 4 (four) qualified bidders matching L1 rates. However, a single vendor shall have to execute the quantity as per BOQ-1. Total quantity of work (as per "BOQ-1") can vary to any extent but the rate finalized will not change up to the completion of the project.

**4.0 COMMENCEMENT OF WORKS:**

The repair work should be started at nominated location(s) as soon as possible but not later than 15 (fifteen) days from the date of issue of Letter of Intent (LOI)/Order failing which, the contract will be terminated and EMD/SD forfeited. This period can be extended on merit on application by contractor.

**5.0 PERIOD OF CONTRACT**

Time is the essence of this contract. Period of Contract shall be for **12 (twelve) months** and the date of commencement will be considered the date of issue of letter of intent (LOI) or work order whichever is earlier.

**NOTE:**

- a) The RDSO drawing series may be changed by East Central Railway, Hajipur. In that case the fabrication agency shall be bound to carry out the

fabrication work as per the said changed RDSO series without any other claim to BBJ on account of such changes.

- b) Target dates indicated above may be modified by BBJ as per requirement of East Central Railway, Hajipur and no claim will be entertained on this account.

If the overall completion schedule needs to be extended due to any reason which is solely beyond the control of the agency and causing hindrance to work progress the said extension of completion schedule shall be granted without L.D. subject to the receipt of extension of completion schedule by BBJ and/or from RAILWAY without L.D.

**6.0 UNIT PRICE**

Unit rate of the work will be per items mentioned in BOQ.

Price shall be inclusive of mobilization, demobilization, manpower, consumables cost, all cost of infrastructure, plant & equipment, all charges towards labour and supervisory charges, transportation, tools and tackles, consumables, POL, enabling & protection works, scaffolding, testing and all applicable taxes, insurance, statutory, incidental charges, supervision, overheads, profit, obtaining permissions from local bodies and any other charges that may be necessary to be incurred for successful completion of your scope of work of fabrication on time.

**7.0 VALIDITY**

The Rates for fabrication will be valid and remain firm for the entire duration of the work order. No revision / alterations of unit rates shall be entertained.

**8.0 TAXES & DUTIES**

- i) The price is inclusive of all taxes and duties (including Service Tax) and incidental charges and all other local taxes, duties including WCT etc. No escalation or any variation in the prices is payable to the agency on account of any increase or modification in the tax structure or introduction/modification of existing levy structure. Income Tax & WCT at prevailing rate shall be deducted from the Agency's bills. BBJ will issue necessary TDS certificate for such deductions.
- ii) If any Entry Tax is leviable, the same should be paid by The Agency on behalf of the purchaser for which no reimbursement will be made by Railway.
- iii) Bidders are required to clearly mention all the applicable tax in their quotation.

**SPECIAL CONDITION OF THE CONTRACT**

**9.0 SUBMISSION OF BILLS AND TERMS OF PAYMENTS**

Payment will be made progressively on receipt of bills after completion of works duly certified by Engineer In-Charge of BBJ/Railway in the following manner;

- i) A Tax Invoice shall be submitted by the Agency twice in a month for the work completed during previous two weeks on or before the date fixed by BBJ. Payment will be released stage wise based on the fortnightly certified bill basis and after receipt of corresponding payment from RAILWAY by BBJ.
  - a. 95% (ninety-five percent) of the accepted bill value will be released after receipt of corresponding payment from Principal Client/Railway.
  - b. Balance 5% (five percent) of the accepted bill value will be released after submission and approval of reconciliation statement of raw steel and return of surplus steel and scraps to BBJ's designated place. However, the agency must submit part reconciliation statement after completion of the 50% (fifty percent) of the scope of work.
- ii) The Agency has to submit pre-receipted bill in triplicate along with necessary Inspection certificates to BBJ.
- iii) The amount payable to The Agency against the final bill shall be released only on submission of the following document;
  - No Claim Undertaking confirming that the "The Agency" has no claims of any nature against the work order and/ or the work done against the work order.
  - Unconditional acceptance of the final bill and measurements entered therein.
  - Unconditional Undertaking that The Agency' has complied in full with the Legal / Statutory obligations with regard to the labour engaged by him on the job including payment of terminal benefits, if any, and that he indemnifies BBJ of any obligation / liability that may arise owing to any representation of any workmen employed by him.
  - A Clearance Certificate from BBJ confirming no short-fall of any material issued to him for the purpose of the work.

**10.0 FREE ISSUE AND RECONCILIATION OF RAW STEEL**

Consumables like cutting gasses, welding electrodes/wires/CO2/O2/LPG, different components of Railway Wagons, paint and Raw Steel required for the work will be supplied by BBJ. However, the said items are subject to reconciliation.

Raw steel will be supplied by BBJ at designated site located at Mughalsarai and the work to be carried out by the Agency at the same place. Safe keeping of raw steel materials will be fabricator's responsibility.

**SPECIAL CONDITION OF THE CONTRACT**

**Mode of Reconciliation of Raw Steel:**

- a) **Wastage:** 5% (five percent) of material list weight shall be allowed as wastage of steel in the process of fabrication work.
- b) **Reconciliation:** The fabricator shall prepare reconciliation statement as per the following table and got the same approved by BBJ.

Reconciliation of steel shall be done on completion of 50% of fabrication and subsequently on completion of entire scope of work. Reconciliation of steel shall deemed to be completed only after receipt of surplus steel as indicated in column (d) above to BBJ's designated place.

The agency shall be liable to return all surplus steel beyond the said quantity to BBJ in the form of scrap and off-cut and full length steel within 3 (three) months from the date of completion of the work. If the agency fails to return the aforesaid surplus steel, BBJ shall recover the cost of surplus steel based on prevailing market price on or about the date of completion plus cost of transportation of steel from agency's work shop to BBJ's premises in Kolkata/ other place plus clerkage charge @ 5% of total value of steel/consumables and transportation cost thereof.

**Bidder should visit site as assigned by Railway before quoting the rate for assessment of accessibility for carrying out the aforementioned scope of work.**

**11.0 PERFORMANCE GUARANTEE**

As security for proper and faithful fulfilment of the obligation under the order, the contractor shall furnish to us Performance Guarantee equivalent to 5% (five percent) of the total Contract Value of the Order by Bank Draft or in the form of a Bank Guarantee of equivalent amount from a Nationalized Bank (as per format to

be provided by BBJ) within 15 (fifteen) days from the date of issuance of LOI/ order in favour of "The Braithwaite Burn And Jessop Construction Company Limited". The Performance Guarantee should be kept valid for further **6 (six) months** from the date of completion of entire work vis-à-vis on acceptance of last consignment by BBJ/ Railway i.e. up to end of Defect Liability Period.

**12.0 SECURITY DEPOSIT:**

As security for proper and faithful fulfilment of the obligation under the order, Security Deposit shall be **Rs.2,50,000/- (Rupees two lac fifty thousand only)** and should be kept valid for further **6 (six) months** from the date of completion of entire work vis-à-vis on acceptance of last consignment by BBJ/ Railway i.e. up to end of Defect Liability Period. Security Deposit shall be in the following manner;

- a) The Earnest Money deposited by the contractor along with the tender will be retained by the BBJ as Security Deposit.

Security Deposit & Performance Guarantee shall be returned to the contractor after completion of entire Order plus 06 (six) months i.e. after the end of Defect Liability Period and subsequent to the following:

- a. After passing the final bill based on "No Claim Certificate" with the approval of the Competent Authority.
- b. Submission of an unconditional & unequivocal 'No Claim Certificate' from the concerned contractor. This certificate, inter alia, should mention that the work has been completed in all respects and that all the contractual obligations have been fulfilled by the contractor and that there is no due from the contractor to BBJ against the contract concerned.

**13.0 WORKING HOURS**

- 1) The Agency has to work for 24 hrs., 7 days a week in open in all-weather condition to achieve the target. In case of any change in the timings, permission shall be taken from Sr.DME/C&W/MGS.
- 2) Adequate staff, supervisor, operator shall be provided by The Agency at his own cost. The Agency will take care of all local issues and environment for the work shop. The staff deployed should be capable of attending all the body repairs, so as to make the wagon fit within 48 hrs.

**14.0 WATCH & WARD**

The contractor is responsible for watch and ward of the materials. The price quoted by The Agency are inclusive the watch and ward expenses and no extra claim will be entertained for deployment of watch and ward or loss, damage of machinery/ materials at work shop.

**SPECIAL CONDITION OF THE CONTRACT**

BBJ shall not be liable for the loss or damage of any of The Agency's equipment, machineries and temporary works.

**15.0 INSURANCE**

THE AGENCY shall be responsible for making good to the satisfaction of BBJ any loss or damages to properties belonging to BBJ or being executed or being procured by RAILWAY if such loss or damages have occurred due to The Agency's work. The Agency at his own cost shall take out, maintain and arrange for the provisions of the following insurance in such terms and of such duration and of such limits as shall be acceptable during the performance of his obligations under the contract within 30 days from the start of work, failing which no RA bill payment will be made to him. The Agency shall secure insurance for the Plant and

machinery deployed under Construction Plant and Machinery Policy and submit the copy of the policy to BBJ/ RAILWAY prior to commencement of the work.

Group Personnel Accident Insurance covering The Agency's employees will be arranged by The Agency. Any such other insurance as may be required of The Agency by statutory bodies and local law in area of his operation will be the responsibility of The Agency.

**16.0 DELIVERY SCHEDULE:**

Following delivery schedule to be adhered by the Agency to meet the target completion schedule by the successful bidder:

**For L1/L2/L3/L4 Bidder:** To meet the requirement, all the Bidders/Agency should carryout fabrication work **within 48 (forty-eight) hours** from taking over a Railway Wagon.

However, it may be noted that delivery schedule for all the above bidder (i.e. L1/L2/L3/L4) shall vary in case of repair job to be re-done and suitable arrangement to be done to meet the delivery criteria.

**17.0 WORKMEN COMPENSATION INSURANCE**

The Agency shall submit proof of Workmen Compensation Policy for all their workmen/ supervisor and any other personnel whom The Agency will deploy for our Project work prior to commencement of the work.

**18.0 DEFECT LIABILITY PERIOD**

The Agency shall fully guarantee all work as per scope of this tender/ order perform strictly in accordance with the drawings, specifications etc. The work shall be free from all defects. Should any work not performed as intended or proved defective within a period of **6 (six) months** from the date of completion of entire or vis-à-vis receipt of last accepted consignment, the work shall upon notification

of deficiency/ defect be promptly rectified by the Agency to the satisfaction of RAILWAY and/or RITES and/or any other Inspection Agency appointed by RAILWAY without any delay and at no extra cost to BBJ. If the Agency fails to effect proper replacement within a reasonable time of receipt of BBJ's notification to this effect, BBJ shall be free to take such corrective action at the Agency's risk and cost.

**19.0 PROVIDENT FUND**

The Agency will be required to cover all their workmen engaged by them under provident fund from the commencement of the work. The Agency will have to submit the challan of payment made towards P.F. for their labour and staff to BBJ's Accounts department every month failing which no RA bill payment will be made.

**20.0 STATUTORY COMPLIANCE**

THE AGENCY shall ensure strict compliance of all labour laws, Minimum Wages Act, Payment of Wages Act, Industrial Disputes Act, Payment of Bonus Act, Contract Labour (Abolition & Regulation) Act, ESI Act, PF Acts, Industrial Safety regulations, laws pertaining to use/ storage of explosives for the work. The Agency shall submit to BBJ the required documents as a proof.

**21.0 DOCUMENTATIONS**

Sub-Contractor/ fabrication agency/ fabricator is to maintain required documentation in registers as per RDSO standard B1- latest revision pertaining to Fabrication Work to be carried out in his workshop in consultation to Engineer In-Charge.

**22.0 QUALITY PLAN:**

The execution of awarded work shall be as per the approved QAP & WPS of the wagon.

**23.0 CONFIDENTIALITY OF DOCUMENTS**

THE AGENCY shall treat all documents, specifications, drawings and contents therein as private and confidential.

**24.0 SUBLETTING OF WORK**

No part of Work Order nor any share or interest thereof shall in any manner of degree be transferred, assigned or sublet by THE AGENCY directly or indirectly to any firm or corporation whatsoever without the prior consent in writing of BBJ

**SPECIAL CONDITION OF THE CONTRACT**

**24.0 INSPECTION OF WORKS**

BBJ/ RAILWAY's/RITES's representatives or Engineer-In-Charge will have full power and authority to inspect the works at work shop or site, at any time and THE AGENCY shall afford or provide for Engineer-In-Charge every facility and assistance to carry out such inspection. The Agency shall at all times during the usual working hours and all other times at which reasonable notice of the intention of Engineer-In-Charge or his representative to visit the works shall have been given, The Agency's representative duly accredited in writing, be present for the purpose.

**25.0 ORGANIZATION CHART**

The Agency will submit his organization Chart showing the name, designation and experience of the personnel.

**26.0 SAFETY AND ENVIRONMENT AT SITE**

The Agency shall strictly abide by all safety standards, specification, practices, rules and regulations in construction and also the instruction of our safety (EHS) Engineer. Any kind of unsafe action or unsafe method of work by The Agency's workmen, which may lead to injury to The Agency's workmen, will be viewed seriously and penalty for the same will be levied on The Agency for such unsafe actions. The Agency will be responsible for the safety of The Agency's staff and employees of other agencies working in The Agency's area of operation. The Agency shall delegate the responsibility of implementation of safety rules to one of The Agency's staff. All safety appliances required like safety helmets, safety belts, shoes, retro reflective jackets and other Safety PPE, etc., shall be arranged by The Agency at The Agency's cost. In the event of non-availability of such safety gadget at required point of time, we may, at the sole discretion of the Site in charge, procure such gadgets and issue the same to The Agency on chargeable basis on actual plus 20 % over head charges.

The Agency's authorized representative shall attend all safety meetings convened by site safety (EHS) Engineer, and abide by his instructions and follow the site safety practices without failure.

Night working: Utmost care shall be taken during night operations with proper illuminations and safety.

**27.0 GENERAL**

The Work Order shall be deemed to be effective only after The Agency

- Submits Performance Guarantee
- License regarding engagement of workers in the contract works from Labour Department or to submit undertaking

- Submits ESI, PF, Group Insurance Certificate and other statutory requirements.
- Submit proof for Insurance of Construction Plant & Machinery
- Sign the work order/ LOI
- Submits State VAT Registration Certificate
- Submits Service Tax Registration Certificate

**27.0 LIQUIDATED DAMAGES**

The fabricator/ agency/ fabrication agency/ sub-contractor shall submit a detailed construction delivery program for completion of work as per order along with schedule of matching resources deployment proposed within 7 (seven) days from issue of LOI/Order.

In order to ensure progress during execution of the work, the agency will be expected to achieve the milestone targets ahead of dates including overall monthly targets. Failure to accomplish milestone targets within allocated time

frame shall create and constitute ground for failure on the part of agency for maintaining progress of the work as per agreed programme sufficient enough to recover liquidated damage as per following(s);

- (a) The penalty for detaining a wagon under fabrication/repair on contractor's account for more than 48 hrs. (from handing over of wagon) shall be Rs.50/- (Rupees Fifty) per wagon per hour.
- (b) In case of poor workmanship repair work will have to be re-done besides penalty for detention of wagons as above will also be imposed.
- (c) In case of delays beyond control of the contractor, waiving off of the penalties may be considered by BBJ and/or Sr. DME/C&W/MGS on merit.
- (d) In case of any damage to the Railway property due to rough handling in the course of attention of repairs or fire on contractor's fault, the cost of damage will be recovered as per the extent of damage assessed by the respective Depot In-charge.
- (e) The decision of BBJ and/or Sr. Divisional Mechanical Engineer, MGS division, East Central Railway regarding the imposition of penalties shall be final and binding on the contractor.

In the event of work cannot be completed within the specified overall completion schedule due to reasons solely attributable to the agency, extension of time may be granted with LD @ 0.5% of contract value per week of delay subject to maximum 5% of contract value.

**28.0 VARIATION IN QUANTITY**

+/- 30% (thirty percent) of the ordered quantity.

**SPECIAL CONDITION OF THE CONTRACT**

**29.0 RISK PURCHASE:**

In the event of failure on the part of the contractor to complete the job within the reasonable period of time as decided by BBJ, BBJ reserves the right to get the job done by other Agency/ Agencies as per the order on Risk Purchase basis and shall recover the extra cost thereof, if incurred, from the contractor.

**30.0 TERMINATION OF CONTRACT**

In the event The Agency's progress is consistently found to be below the accepted pace based on the program as indicated of this document and/or if the quality of works being executed by The Agency falls below the expected standards laid down by us, in such cases, in the interest of timely and successful completion of the project and to maintain the high quality of work, we reserve the right to delete The Agency's scope of work, or, the entire balance work to be taken away from The Agency and BBJ shall be at liberty to get such works executed by other agencies and in such case we shall not be liable to pay any compensation or make good any damage/s or effect any other payment to The Agency for anticipated reduction in profit or any other ground whatsoever.

All statutory obligations including maintaining the RTO rule, rules of local Govt. bodies should be abide by The Agency and any consequence comes out from The Agency's act which can result stoppage of work, BBJ will consider the same as non-performance of The Agency. BBJ reserves the right to terminate the contract with that effect and no compensation will be paid for the same.

**31.0 RESOLUTION OF DISPUTES AND ARBITRATION**

All disputes or difference of opinion on account of interpretation of clauses, Technical specification etc., shall be resolved through direct and mutual discussions at site level. In the case of differences of opinion still persisting, the agency shall refer the same to the Managing Director /BBJ for amicable solution/ settlement. Managing Director/BBJ and/or his authorized representative shall take up the same with concerned official of RAILWAY for settlement.

In case of difference in opinion still persists, the same shall be referred to the sole arbitrator, to be appointed by IC head of Transportation Infrastructure IC, RAILWAY for adjudication as per arbitration and conciliation Act, 1996 and the effect of the result shall be passed on to the agency.

**32.0 OTHER IMPORTANT CONDITONS OF CONTRACT:**

- 1) The contractor shall submit the detail of manpower (with particulars like, Name, Father's name, Address, Age, Passport size photo) that would be utilized for the work to the depot in-charge and any change in the manpower shall be communicated to the depot in-charge in writing. This should be submitted before taking of the job inside the Depot/Yard premises at the beginning of the work as well as in between as and when any of his employees is replaced with the new employee.

**SCC-12**

**SPECIAL CONDITION OF THE CONTRACT**

- 2) The contractor shall provide identity card to all those employees deputed to work who shall carry out the said work. The ID card shall carry the photograph, name, father's name, address, contact no. etc. The contractor's name, address and contact no. shall also be printed on the back side of the identity card. The concerned Depot/Yard in charge shall inform RPF authority regarding the contractor's employee deputed to work inside the Depot/Yard premises as per the said bio-data. Those employees carrying proper identity card, details of which have been submitted to concerned Depot/Yard in charge will be only allowed to work inside the Depot/Yard premises.
- 3) The contractor shall not allow anybody to use the premises for any purpose other than that is permitted under the contract.
- 4) The contractor shall ensure that the workmen engaged by him do not indulge in any indecent behaviour or create disturbance in the workplace during the course of work, failing which the contract shall be liable to be terminated.
- 5) No accommodation shall be given to any contractor(s) staff/supervisors for the purpose of stay. No railway Pass/PTO shall be admissible to the men engaged by the contractor.
- 6) The contractor shall provide safety equipment, Industrial helmet and safety shoes to all the employees and shall ensure the use of the same by his staff while on duty.
- 7) The contractor shall be responsible for the safety of the staff deployed during the course of the work. No claim/compensation would be entertained by the railway for any type of accident/incident involving his staff. Any compensation, as required under the law would be payable by the contractor.
- 8) The cost of damage to the railway property, if caused by the contractor during the execution of work will be charged on the contractor.
- 9) Any misuse of Railway property will be viewed seriously and the actual cost with penalty will be recovered from the contractor's bills.
- 10) The contractor shall follow the instructions of depot in charge/his representative in execution of the services.
- 11) The stationery required for maintaining the daily formats and other registers are to be supplied by the contractor.
- 12) The entire work area including the railway track shall be kept free of any obstruction / debris released from the wagons repaired by the contractor (for placement and drawals of wagons) on the same day.
- 13) The contractor must ensure compliance of all labour laws and safety measures for his staff as applicable.
- 14) Sufficient stock of material on site should be ensured by the contractor.
- 15) Road Permit shall be issued by Sr.DME(C&W)/MGS as and when required. However, payment of all types of taxes/duties, etc. or any other cost associated with issuing of the Road Permit shall be borne by the contractor.
- 16) Contractor will be responsible for safety & security of stores/stored material to be used for repair of wagons.
- 17) In case wagons are not offered due to unforeseen circumstances contractor will have no claim for compensatory payment.

- 18) Length of welding to be done for each patch or elsewhere will be as per instruction of Railway Representative. Payment for welding will be made based on actual welding length as measured and certified during final inspection by Railway Representative.
- 19) "Engineer" as referred in GCC shall be read as "Sr. Divisional Mechanical Engineer/ C&W/ MGS" or "Divisional Mechanical Engineer/ C&W/ MGS" or "Asst. Mechanical Engineer/ C&W/MGS" or BBJ's Engineer.
- 20) The Contractor shall adhere to the Labour Rules, Workmen Compensation Act and Payment of minimum wages Act and other Labour legislation's.
- 21) The Contractor shall furnish complete details of the personnel to be deployed with supervisor(s) giving the working timings. The name/list of all the employees along with supervisor should be submitted.
- 22) The contractor shall comply with the provision of the hours of the employment regulations in respect of the staff employed, by him in the manner decided upon by the appropriate authorities.
- 23) All direct or indirect costs and obligations pertaining to employment of specialized manpower if any will be borne by the contractor.

**PRE CONTRACT INTEGRITY PACT**

**PCIP-1**

**General**

This pre-bid pre-contract Agreement (hereinafter called the Integrity Pact) is made on \_\_\_\_\_ day of the month of \_\_\_\_\_ 20....., between on one hand, THE BRAITHWAITE BURN & JESSOP CONSTRUCTION COMPANY LIMITED, 27, Rajendra Nath Mukherjee Road, Kolkata – 700 001 (hereinafter called the "BUYER", which expression shall mean and include, unless the context otherwise requires, its successors in office and assigns) of the First Part and M/s \_\_\_\_\_ represented by Sri \_\_\_\_\_ (Designation) (hereinafter called the "BIDDER/Agency" which expression shall mean and include, unless the context otherwise requires, his successors and permitted assigns) of the Second Part.

WHEREAS the BUYER proposes to procure/contract for NIT/DGM(P-V)/WAGON REPAIR/MUGHALSARAI/2148/3129 Dated 8<sup>th</sup> April, 2016 and the BIDDER/Agency is willing to offer/has offered the same and

WHEREAS the BIDDER is a Private Company/ Public Company/ Government Undertaking/ Partnership/ Registered Export Agency, constituted in accordance with the relevant law in the matter and the BUYER is a PSU performing its function on behalf of the President of India.

NOW, THEREFORE,

To avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to: -

Enabling the BUYER to obtain the desired said stores/ equipment/ contract at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and

Enabling BIDDERS to abstain from bribing or indulging in any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the BUYER will commit to prevent corruption, in any form, by its officials by following transparent procedures.

The parties hereto hereby agree to enter into this Integrity Pact and agree as follows:

**Commitments of the BUYER**

1.1 The BUYER undertakes that no official of the BUYER, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the contract.

**PCIP-2**

- 1.2 The BUYER will, during the pre-contract stage, treat all BIDDERS alike, and will provide to all BIDDERS the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDDERS.
- 1.3 All the officials of the BUYER will report to the appropriate Government Office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such a breach.
2. In case any such preceding misconduct on the part of such official(s) is reported by the BIDDER to the BUYER with full and verifiable facts and the same is prima facie found to be correct by the BUYER, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the BUYER and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the BUYER the proceedings under the contract would not be stalled.

**Commitments of the BIDDERS**

3. The BIDDER commits itself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commit itself to the following: -
  - 3.1 The BIDDER will not offer, directly or through intermediaries, any bribe, gift consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees brokerage or inducement to any official of the BUYER, connected directly or indirectly with the bidding process, or to any person, organisation or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the contract.
  - 3.2 The BIDDER further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees brokerage or inducement to any official of the BUYER or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other contract with the Government/the Company for showing or forbearing to show favour or disfavour to any person in relation to the contract or any other contract with the Government/the Company.
  - 3.3\* BIDDERS shall disclose the name and address of agents and representatives and Indian BIDDERS shall disclose their foreign principals or associates.
  - 3.4\* BIDDERS shall disclose the payments to be made by them to agents/brokers or any other intermediary, in connection with this bid/contract.
  - 3.5\* The BIDDER further confirms and declares to the BUYER that the BIDDER is the original manufacturer/integrator/authorized government sponsored export entity of the defence stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the BUYER or any of its functionaries, whether officially or unofficially to the award of the contract to the BIDDER, nor has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation or recommendation.

**PCIP-3**

- 3.6 The BIDDER, either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payments he has made, is committed to or intends to make to officials of the BUYER or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.
- 3.7 The BIDDER will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.
- 3.8 The BIDDER will not accept any advantage in exchange for any corrupt practice, unfair means and illegal activities.
- 3.9 The BIDDER shall not use improperly, for purposes of competition or personal gain, or pass on to others, any information provided by the BUYER as part of the business relationship, regarding plans, technical proposals and business details, including information contained in any electronic data carrier. The BIDDER also undertakes to exercise due and adequate care lest any such information is divulged.
- 3.10 The BIDDER commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.
- 3.11 The BIDDER shall not instigate or cause to instigate any third person to commit any of the actions mentioned above.
- 3.12 If the BIDDER or any employee of the BIDDER or any persons acting on behalf of the BIDDER, either directly or indirectly, is a relative of any of the officers of the BUYER, or alternatively, if any relative of an officer of the BUYER has financial interest/stake in the BIDDER's firm, the same shall be disclosed by the BIDDER at the time of filing of tender.  
The terms 'relative' for this purpose would be as defined in Section 6 of the Companies Act 1956.
- 3.13 The BIDDER shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee of the BUYER.

4. **Previous Transgression**

- 4.1 The BIDDER declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public Sector Enterprise in India or any Government Department in India that could justify BIDDER's exclusion from the tender process.
- 4.2 The BIDDER agrees that if it makes incorrect statement on this subject, BIDDER can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason.

5. **Earnest Money (Security Deposit)**

- 5.1 While submitting commercial bid, the BIDDER shall deposit an amount Rs. 2,50,000/- (Rupees two lac fifty thousand only) (to be specified in RFP) as Earnest Money/ Security Deposit, with the BUYER through any of the following instruments:
- (i) Bank Draft or a Pay Order in favour of "The Braithwaite Burn and Jessop Construction Co. Ltd." payable at Kolkata.
  - (ii) A confirmed guarantee by an Indian Nationalised Bank, promising payment of the guaranteed sum to the BUYER on demand within three working days without any demur whatsoever and without seeking any reasons whatsoever. The demand for payment by the BUYER shall be treated as conclusive proof of payment.
  - (iii) Any other mode or through any other instrument (to be specified in the RFP)
- 5.2 The Earnest Money/ Security Deposit shall be valid up to a period of five years or the complete conclusion of the contractual obligations to the complete satisfaction of both the BIDDER and the BUYER including warranty period, whichever is earlier.
- 5.3 In case of the successful BIDDER a clause would also be incorporated in the Article pertaining to Performance Bond in the Purchase Contract that the provisions of Sanctions of Violation shall be applicable for forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
- 5.4 No interest shall be payable by the BUYER to the BIDDER on Earnest Money/Security Deposit for the period of its currency.

6. **Sanctions for Violations**

- 6.1 Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the BUYER to take all or any one of the following actions, wherever required: -
- (i) To immediately call off the pre contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with other BIDDER(s) would continue.
  - (ii) The Earnest Money Deposit (in pre-contract stage) and/or Security Deposit/ performance Bond (after the contract is signed) shall stand forfeited either fully or partially, as decided by the BUYER and the BUYER shall not be required to assign any reason therefore.
  - (iii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER.
  - (iv) To recover all sums already paid by the BUYER, and in case of an Indian BIDDER with interest thereon at 2% higher than the prevailing Prime Lending Rate of State Bank of India, while in case of a BIDDER from a country other than India with interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to the BIDDER from the BUYER in connection with any other contract for any other stores, such outstanding payment could also be utilised to recover the aforesaid sum and interest.
  - (v) To encash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the BUYER, along with interest.



**PCIP-5**

- (vi) To cancel all or any other Contracts with the BIDDER. The BIDDER shall be liable to pay compensation for any loss or damage to the BUYER resulting from such cancellation/rescission and the buyer shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.
  - (vii) To debar the BIDDER from participating in future bidding processed of the Government of India/the Company for a minimum period of five years which may be further extended at the discretion of the BUYER.
  - (viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middleman or agent or broker with a view to securing the contract.
  - (ix) In cases where irrevocable Letters of Credit have been received in respect of any contract signed by the BUYER with BIDDER, the same shall not be opened.
  - (x) Forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
- 6.2 The BUYER will be entitled to take all or any of the actions mentioned at para 6.1(i) to (x) of this pact also on the Commission by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) of an offence as defined in chapter IX of the Indian Penal code, 1860 or Prevention of Corruption Act, 1988 or any other statute enacted for prevention of corruption.
- 6.3 The decision of the BUYER to the effect that a breach of the provisions of this Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the Independent Monitor(s) appointed for the purposes of this Pact.
7. **Fall Clause**
- 7.1 The BIDDER undertakes that it has not supplied/is not supplying similar product/systems or subsystems at a price lower than that offered in the present bid in respect of any other Ministry/Department of the Government of India or PSU and if it is found at any stage that similar product/systems or sub systems was supplied by the BIDDER to any other Ministry/Department of the Government of India or a PSU at a lower price, then that very price, with due allowance for elapsed time, will be applicable to the present case and the difference in the cost would be refunded by the BIDDER to the BUYER, if the contract has already been concluded.
8. **Independent Monitors**
- 8.1 The BUYER will appoint Independent Monitors (hereinafter referred to as Monitors) for this Pact in consultation with the Central Vigilance Commission (Names and Addresses of the Monitors to be given).
- 8.2 The task of the Monitors shall be to review independently and objectively, whether and to what extent the parties comply with the obligations under this Pact.
- 8.3 The monitors shall not be subject to instructions by the representatives of the parties and perform their functions neutrally and independently.
- 8.4 Both the parties accept that the Monitors have the right to access all the documents relating to the project/procurement, including minutes of meetings.

**PCIP-6**

- 8.5 As soon as the Monitor notices, or has reason to believe, a violation of this Pact, he will so inform the Authority designated by the BUYER.
- 8.6 The BIDDER(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the BUYER including that provided by the BIDDER. The BIDDER will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor shall be under contractual obligation to treat the information and documents of the BIDDER/Subcontractor(s) with confidentiality.
- 8.7 The BUYER will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the parties. The parties will offer to the Monitor the option to participate in such meetings.
- 8.8 The Monitor will submit a written report to the designated Authority of BUYER/Secretary in the Department/within 8 to 10 weeks from the date of reference or intimation to him by the BUYER/BIDDER and should the occasion arise, submit proposals for correcting problematic situations.

9. **Facilitation of Investigation**

In case of any allegation of violation of any provisions of this Pact or payment of commission, the BUYER or its agencies shall be entitled to examine all the documents including the Books of Account of the BIDDER and the BIDDER shall provide necessary information and documents in English and shall extend all possible help for the purpose of such examination.

10. **Law and Place of Jurisdiction**

This Pact is subject to Indian law. The place of performance and jurisdiction is the seat of the BUYER.

11. **Other legal Actions**

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

12. **Validity**

- 12.1 The validity of this Integrity Pact shall be from date of its signing and extend up to end of Defect Liability Period or the complete execution of the contract to the satisfaction of both the BUYER and the BIDDER/Seller, including warranty period, whichever is later. In case BIDDER is unsuccessful this Integrity Pact shall expire after six months from the date of the signing of the contract.
- 12.2 Should one or several provisions of this Pact turn out to be invalid, the reminder of this Pact shall remain valid. In this case, the parties will strive to come to an agreement to their original intentions.

i)	The Sub-Contractor must submit a photocopy each of the above Insurance Policy to the Site-In-Charge/BBJ, RAILWAY-KHARSIA Bridge Site before commencement of the work.
