- c) The “**ORDER**” shall mean a written Purchase Order issued by BBJ.

- e) S.E.C. Railway means “South East Central Railway” and/or their Authorized representatives.

2. SCOPE OF SUPPLY:

3. VARIATION IN QUANTITIES:

Variation will be within $\pm 25\%$ of the ordered quantity.

4. SPLITTING OF SCOPE OF SUPPLY

- (a) BBJ reserve the absolute right to split the SCOPE OF SUPPLY in respect of SIZE & QUANTITY among the Techno-commercially qualified bidders as per BBJ’s requirement and decision.

- (d) However, any party will not have any claim towards reduction of such quantity from their scope of supply and such splitting of Scope of Supply will be done at Negotiated Lowest Accepted Rate only.
